# RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM AUTHORIZING THE AWARD OF A CONTRACT TO DEANDREA LAND AND STONE OF BROOKSIDE, NEW JERSEY FOR SNOW PLOW SERVICES

**WHEREAS**, the Township bid and awarded a contract for Snow Plowing services during 2021, which included an option to extend the contract for 2022, and 2023 to DeAndrea Land and Stone of Brookside, New Jersey; and

WHEREAS, DeAndrea Land and Stone and the Township have agreed to renew the option for the period of October 1 2022 through April 30, 2023 at a 4% increase per the bid specifications; and

WHEREAS, the hourly rate per truck (2 trucks included per the bid) based on the 4% increase will be \$197.60; and

**WHEREAS,** the services provided in this bid will be provided for in the 2022 budget from accounts numbered 02-26-291-155— Snow Plow — Contract.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Mendham, County of Morris, State of New Jersey, as follows:

- The Township Committee hereby awards a contract to DeAndrea Land and Stone, of Brookside,

**WHEREAS,** the Township of Mendham is a member of the Educational Services Commission of New Jersey (ESCNJ) Purchasing Cooperative; and

WHEREAS, the Township of Mendham is need of mulch for various parks and playgrounds; and

**WHEREAS,** Downes Forest Products, LLC of Hawthorne, New Jersey offers mulch through the ESCNJ contract # 20/21-02 in an amount of \$12,750; and

**WHEREAS**, the Township of Mendham, pursuant to N.J.S.A 40A:11-11 and N.J.A.C. 5:34-7.1, may by resolution purchase any goods or services from approved Cooperative Purchasing programs; and

**WHEREAS,** the Township of Mendham is a member of the Educational Services Commission of New Jersey (ESCNJ) Purchasing Cooperative; and

WHEREAS, the Township of Mendham is in need of a generator for the new Police Headquarters; and

**WHEREAS,** Foley Power Systems of Piscataway, New Jersey offers a Caterpillar Emergency Generator System through the ESCNJ contract # 21/22-11 in an amount of \$107,804; and

**WHEREAS,** the Township has applied for and anticipates receiving a grant from the New Jersey Office of Emergency Management, FFY22 EMMA in an amount of \$20,000 to be applied to the cost of the generator; and

**WHEREAS**, the Chief Financial Officer has certified as to the availability of funds pursuant to *N.J.A.C. 5:30-5.4*, said funds to be encumbered as follows:

General Capital Fund C-04-55-028-006 \$75,000 Other Trust - Police Outside Detail – Admin Fees \$32,804

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Township Committee of the Township of Mendham, County of Morris, State of New Jersey authorizes the Mayor and the Township Clerk to enter into a contract with Foley Power Systems of Piscataway, New Jersey, in an estimated amount of \$107,804 for the purchase of a generator.

**WHEREAS,** the Township Committee of the Township of Mendham is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq.; and

**WHEREAS,** the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Township Committee of the Township of Mendham to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below: (1) Matters Required by Law to be Confidential: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act. (2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States. (3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly. (4) Matters Relating to Collective Bargaining Agreements: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body. (5) Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed. (6) Matters Relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law. (7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege: Any pending or anticipated litigation or contract negotiation in which the public body is, or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer. |X|(8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose right could be
