## PLANNING BOARD NOMINATIONS

Ms. Duarte nominated Committee member Tom Baio to the position of member of the Planning Board and Mr. Orlins seconded the nomination.

Motion to call the question made by Mr. Monaghan and second by Ms. Duarte.

Roll call vote: All members present voted to approve.

Mayor Neibart designated the Mayor's role on the Planning Board to Deputy Mayor Monaghan.

## STATEMENT BY THE MAYOR / COMMITTEE MEMBERS

Mr. Monaghan welcomed the new Township Committee members, Tom and Jordan. He also thanked everyone in the audience especially the Fire and First Aid volunteers for supporting the community. He congratulated Mayor Neibart and wished her all the best for a successful year and he looks forward to working with her to help Mendham Township grow and prosper. Mr. Monaghan is excited about the possibilities that this year holds, he noted that the finances are strong and the debt is being paid down at a considerable rate. The paid staff at Town Hall, Police Department and DPW continues to perform at a high level, demonstrating why Mendham Township is a desirable place to live and work. These are great foundations for a successful year and he looks forward to working with the committee to build on that foundation.

Ms. Duarte's statement attached hereto and made part of the minutes.

Mr. Baio thanked the public for their support in helping him arrive at the dais. He expects to bring his professional experience to bear on the formation of policy, affecting the statutory and regulatory obstacles which affect private re-investment in the town. He expects that these changes in a small way will seek to curve and perhaps sustain property value increases in both the mid and long term. He takes it upon himself to foster anything that he can do to encourage private re-investment both from the resident community and the developer community. As he said during his campaign, the greatest vote that a citizen in the township can cast, is not a vote for him or one of the other Township Committee members but rather a vote to cut their lawn, paint their home, or otherwise improve the residence that they live. The community pride and the spirit that is shown both in the form of private reinvestment in a home as well as in the decoration, floral arrangements and holiday set-up is exactly what makes Mendham Township a great town. He hopes we can effectuate a little bit of the statutory and regulatory obstacles that might prevent someone from doing that.

Mr. Orlins expressed that he has a short story and a request. He moved to Mendham Township in 2007. In that year, the property tax rate was 1.5% and today the property tax rate will be around 2.2% which is more than a 40% increase. He expressed, a noted that everyone can agree, that this is a bad trend. He noted that this trend is specifically the reason why he chose to run for and serve on the committee.

Mr. Orlins provided an example on ratios noting that on the top of the ration you have "property taxes" and on the bottom of the ratio you have "property values." He explained that both parts of this equation is going in the wrong direction. Since 2007, taxes are generally going up and values are generally going down and noted that all have experienced this.

Mr. Orlins explained that property values are driven primarily by job growth and unfortunately for New Jersey our state's corporate tax and regulatory regime are the worst in the nation and on net is driving companies to other states. He expressed that on the other hand, fortunately, the Township Committee controls the municipal portion of the property tax bill. He expressed that we have the ability, if we have the will, to make dramatic improvements to our efficiency as a township, to lower municipal spending, stop the growth in our tax rate and make the town more attractive relative to other towns in the area.

Now, that gets him to his request which is to hold the Township Committee accountable. He noted that he and Tom (Baio) came with a long list of ideas to make the town more efficient, many of these ideas they got from the taxpayers, while campaigning. He noted that they are already working them but they need the help from residents. He asked the residents to attend the Township Committee meetings and ask them, what they are doing to lower taxes. He expressed that 4/5 of the committee members ran on lower taxes as their #1 priority. He noted that it is the #1 issue for him and Tom and it is the first issue on Sarah and Nick's campaign website. His request to the resident is to hold the Township Committee accountable.

HEARING PERSONS PRESENT - Mayor Neibart opened the meeting to the public.

**Pratip Chattopadhyay** - 12 Brookrace Drive – commented that in a relatively short period of time, there have been two prominent acts of hate and intolerance in community. During his wife's campaign, while knocking on doors, he learned of other cases perhaps not as overwhelming in there details but very clear in the discomfort that they caused and the pain that they resulted in. He expressed that the Township has to condemn in the strongest terms possible with fierce public statements, as quickly as possible, any acts of hate or intolerance in the community. He expressed that when he heard that someone vandalized the public menorah during Hanukkah, it broke his heart – and it should have broken the Township Committee's heart too which the public needed to hear, immediately, afterwards from each committee member. He expressed that the community

needed to hear a statement by the Township via press releases and social media post. He expressed his disappointment with the way the issue was handled because when something like this happens, it cuts the fabric of the community and it tears up the small town decency that makes the community that residents have all chosen happily and eagerly to raise a family. He, respectively, submitted to the committee that the township needs to confront head on the diversity problem – diversity needs to be talked about often and forcefully, forcefully work to show the world that this is not a closed community. He would like to meet with members of the committee to discuss some ideas for action on the issue of diversity. He is looking for the committee's assistance to shape the ideas, believe in the ideas and to participate in the ideas. He commented that governance is not just about property taxes and shared resources; it is about the community the residents want to live in. He suggested the following game plan: (1) forceful, immediate and official condemnation (2) official support for diversity initiatives (3) public building of the Township's reputation on these issues.

**Taylor Buonocore** – 28 Cold Hill Road – congratulated the Township Committee on their new roles. She would like to learn more about the process and criteria for selecting the leadership roles (Mayor and Deputy Mayor) – the interest comes from her professional and business background and also her interest in the town. Her understanding is that the choice, historically, has been made along dominate party lines. Ms. Buonocore expressed some suggestions on how to make a choice when they are two or more qualified people. She suggested making a list of criteria – what makes somebody the right person for the leadership roles. The list she made consist of the following criteria and she hopes to see Mayor Neibart and Deputy Mayor Monaghan rise to those criteria which are accessibility, attendance, results and a deep understanding of the town and community that comes from being out there. She expressed that continuing the involvement in the community is so critical and she looks forward to spending time with the committee members. She did her evaluation and her selection were not necessarily who is, currently, up at the dais. She would hate to feel that the choices, decisions and policy that get made, get made along party lines – she feels everyone is quiet tired of that. She expressed that Warren Gisser left big shoes to be filled and she hopes the committee can look to Warren Gisser's leadership. She is confident that Mayor Neibart will fill those shoes.

Motion to close hearing person present made by Mr. Monaghan and second by Mr. Orlins. All members present voted to approve.

Ms. Duarte thanked the public for speaking up at the meeting which takes a lot of courage. She expressed that she personally did speak out, immediately, on social media and through the newsletter about the acts that occurred. She welcomed the suggestions on what the township can do and she encouraged the members of the public to join the Stigma Free Task Force. She encouraged the public to attend the task force because the focus is to make sure that people are looking at Mendham in terms of buying homes. She assumed we all want to keep our taxes low which is why she did not speak about the topic and contrary to what was said she also ran on shared services and trying to lower taxes. She noted that one of the initiatives that she worked on last year was to bring in a little bit of a decrease in everyone utility bill through energy aggregation. She expressed that its 5 of 5 committee members who want to keep our town running efficiently and keep the taxes as low as possible also while investing in parks, recreation, etc.

# Remarks by Committee member Duarte regarding no vote for Mayor and Deputy Mayor

I will not be voting in favor of this nomination. I was at the high school track meet this afternoon, so sports are on my mind.

We as a Township Committee work together like a team. By virtue of being elected, we all made the team. And as a team we should be allowing full participation by everyone who made it.

The tradition has been to rotate the roles of deputy mayor and mayor among the five members of the Township Committee, so that everyone has an opportunity to fully participate as a leader and to represent the voters.

I'm disappointed — but not surprised — that I am being passed over for the position of mayor, as last year I was passed over for Deputy Mayor. I am effectively being left on the bench and on the sidelines, instead of being put out on the field. So for that reason, I will be voting No.

Good Evening Everyone!

Happy New Year, and Welcome to Mendham Township!

On behalf of the whole Township Committee, I want to thank our Township Administrator Debbie Bonanno and our Township Clerk Maria Coppinger for putting everything together for tonight. I also want to thank our outgoing Mayor Warren Gisser for being here tonight and for his leadership and commitment to this town. As many of you know, 2019 was a busy year for the Township!

- Our Recreation Department revitalized Brookside Beach
- The Ralston Playground finally Opened
- Our Twp. Administrator and DPW Superintendent restructured the Department of Public Works
- Our town received a grant from the State of NJ and a grant from the County of Morris totaling \$642,253 dollars to build the Park at Pitney Farm.
- We expanded and continue to expand Shared Services Opportunities by adding Chester Borough to our Shared Court with Chester Twp. and leading an inter-local services initiative with five other towns for animal control services
- Our Planning Board approved several development applications AND
- We continued making incredible strides in paying down our debt obligations.

Going into this next year, our committee is poised to make even greater improvements. We are a committee of equals - We are a team charged with the responsibility of serving the community together. All of us have initiatives that we are personally focused on and I am sure you will hear some of them later tonight, but something that I think we can all agree on is that property taxes are just too high.

When I joined the Twp. Committee in 2018, property taxes were my number one issue; so the Mayor – at the time - appointed me to the Finance Committee. I quickly realized that our town operates on a pretty slim budget, and within that budget we are obligated to fund the unfunded state mandates and navigate the state regulations. To offset these costs, we work tirelessly to share services and utilize land and buildings for multi-use services, but without a vast retail or commercial district and without a growing rate-able base it is pretty difficult to sustain.

I know the municipal portion of property taxes is only about 20% of the overall property tax levy, **<u>but</u>** I believe it is **<u>my</u>** job and **<u>every person's job</u>** on this dais to do whatever they can in their role to be creative and work to find efficiencies to alleviate the tax burden on our residents.

As Mayor of our town and Chair of the Finance Committee, I believe that we can deliver a budget this year with <u>no</u> property tax increase. There will be tough decisions to be made, but it can be done while also continuing to pay down our debt.

In addition to cutting spending, we need to address our revenue problem. One way is to revise our Master Plan to help broaden our tax base.

Our tax levy is highly dependent on our aggregate assessed value, which we need to grow. We are challenged by our dependence on a tax base that is almost completely residential. We have taken some steps to broaden our tax base through recent approvals of development, and I know that we have applications on the horizon, but we need a proactive approach to this problem. Over the years, a lot has been said about what types of homes new families are looking to buy, and we will have to take a serious look to see if our current zoning standards are conducive to attracting those families. We also need to have a conversation about expanding the retail district that includes the Post Office and Harmony Brookside. I am excited to see what the Master Plan Subcommittee comes up with this year.

Another less traditional way to increase revenues is to encourage residents to focus their Charitable Contributions to our town. We had great success with raising money for the Ralston Playground, and I believe we can continue to succeed in raising money for the Park at Pitney Farm and other projects and initiatives coming down the line.

There are many other ideas out there and I encourage all of you to be part of the conversation in the year to come.

# Chief Witczak's remarks 1/2/2020

Good Evening to the Township Committee and we extend a warm welcome and congratulations to our new committee members and mayor.

The Brookside Engine Company had a very busy 2019 serving our wonderful community. We have a few highlights to share.

In 2019 we answered 306 Calls for service, while it was down 10 calls from the year prior we are averaging 50 calls more these past 2 years then we were 5 years ago.

Our average response time was 12 minutes and 4 seconds and we are still 2 minutes faster on average than the national standard for a community of our size.

In 2019 we welcomed 5 new members – Senior Member Dan Wood and 4 Junior members – Shan Ali, Will Ackerman, Trey Vanderbeek and Kevin Berman.

Our members volunteered a total of 4,042 hours to the community in training, call response, community service events and all of the extra business work that goes into being a part of a volunteer fire department.

With firefighting being a dangerous occupation including a rise in the exposure to cancer causing carcinogens and toxins, we were proud and fortunate to have 0 on the job injuries and 0 occupational known or discovered illnesses to our members in 2019.

Our clambake was the best yet with the highest attendance we have ever had and we look for to all of you joining us again this year, the 1<sup>st</sup> Saturday in September after Labor day, across the street at the Community Club.

We look forward to a great year in 2020 in serving our community.

It will be the first time in 9 years dating back to 2011 that our fleet of apparatus will finally be back to the level and capability that is necessary to maintain our Insurance Services level 3 rating which is among the best in the state. It also enables us to provide the excellent level of service that our citizens have come to know and expect from our fire company.

Even with increased training hours, higher call volume and more commitments than ever, We still have managed to provide a superior level of service while maintaining fiscal responsibility in having the lowest budget in the county.

It's been a pleasure to serve on the Township Committee for the past two years, and I am excited to start the third year of my term. I want to share a few thoughts that I have as we begin 2020:

First, I will continue advocating for transparency and open government. I will keep holding Office Hours to meet with residents; and sending out regular communications through e-mails and on social media. Residents don't always have time to show up for meetings — so we need to be proactive in keeping them informed. And, the feedback I have gotten for the past two years is they want to be informed. With that in mind, I plan to propose reviving the Ad Hoc Communications Committee that was created two years ago and which I chaired. This group worked on updating the town's Website and launching a town newsletter. They had other recommendations that I would like to see us move forward on implementing.

Secondly, last month, we witnessed a beautiful milestone in our community with the first lighting of a menorah — and then the awful vandalism that took place a few days later. It was heartwarming on the last night of Hanukkah to see community members stand together in solidarity to show that we do not tolerate hate in Mendham. There is no place in our community for hate or bigotry because of someone's religion, race, ethnicity or sexual orientation. And, we as elected officials should speak out — loudly against it — when we see it. With that in mind, I want us to pass a Proclamation in support of June as Pride Month. I believe strongly that we should show our support for the LGBTQ community — and especially show a message of inclusion and support to our youth.

That brings me to the third area — the Stigma-Free Task Force. Two years ago, we proclaimed Mendham a Stigma-Free Community, and I created a Mendhams Task Force. I have served as the Chair with the support of volunteers from the Township and the Borough and both Police Chief Johnson and Chief Camoia, from the Borough. We have held workshops on difficult subjects like drug use, Youth Mental Health and Teen Suicide Prevention.

This year, I want us to make this Task Force a permanent Committee across the Mendhams to support the work being done in the schools; to continue sponsoring workshops; and to look for other ways that we as a community can tackle the difficult challenges faced by our young people. These are really tough subjects and conversations to have, but with events that have unfolded in our community over the past two years, and more recently, it's absolutely critical. I hope I will get support for that idea.

Finally, to close, I want to go back to the idea of us — the Township Committee as a team — Team Mendham. I know everyone up here has the best interests of the community at heart and wants to work toward making our town even better.

There is an excellent quote from Michael Jordan: "Talent wins games, but teamwork and intelligence win championships."

With that, I hope, we have a successful 2020 and a year from now can all be proud of what we were able to accomplish on behalf of the residents as a Team.
