Mr. Monaghan expressed his concern with the hiring process, noting that some of the members of the Township Committee have not met with the individual prior to him starting and that the resolution was presented after the fact. Mayor Gisser provided an explanation, noting that the Township Administrator and the liaison to Recreation, Ms. Duarte, interviewed several individuals and provided their recommendation. Ms. Duarte noted that a conversation took place in Executive Session and it is for an interim position. Ms. Bonanno explained that a hiring process was set earlier on and that for certain types of positions she would be able to move forward and make the hire.

Ms. Duarte moved. Mr. Monaghan seconded.

ORDINANCE FOR PUBLIC HEARING/ADOPTION

02 - 2019 An Ordinance of the Township of Mendham in County of Morris and the State of New Jersey Extending Affordability Housing Restrictions on The Corners at Mendham – *Introduction / First Reading was held on February 11, 2019*

Ms. Neibart moved. Ms. Duarte seconded.

Ms. Kelli Gallo from the Buzak Law Office was present to answer questions from the public and members of the Township Committee.

Mayor Gisser noted that if the Township Committee did not act on extending the affordability housing restriction on these units, then the property returns to a market rate unit and there would be a 95% / 5% split on the increase economic value. Ninety-five percent (95%) of the increase economic value would go to the municipality to be held in reserve for the specific purpose of acquiring new housing stock to put into affordable housing and the five percent (5%) of the increase would go to the property owner.

Mr. Monaghan moved. Ms. Neibart seconded.

All members present voted to open the meeting to the public.

No comments on Ordinance 02-2019 were presented from the public.

Mr. Monaghan moved. Ms. Neibart seconded.

All members present voted to close the meeting to the public.

Ms. Duarte expressed that affordable housing is good for our community and it allows us to have a greater social economic mix. She noted that the average Mendham home sold for \$900,000, which not many families could afford, so it is terrific to have opportunities for families to come into the community and take advantage of affordable housing.

Ms. Neibart asked for clarification on the reason to extend for 30 years. Ms. Gallo explained that the original controls were set for 30 years so they decide to extend for another 30 years.

Roll call vote: All members present voted to approve.

DISCUSSION

Mayor Gisser, Ms. Neibart, Ms. Bonanno and a representative from the operator met with the Mendham Sewer East (Drakewick Community) to go over the sewer treatment plan project. He also met with the Pitney Homeowners Association who had a couple of questions on other issues. He noted that the Pitney Presentation/public hearing is scheduled for March 11, 2019. The first reading of the budget is scheduled for March 26, 2019.

Mr. Diegnan thanked Ms. Diana Orban Brown for her efforts on the Pitney project.

Ms. Neibart asked that the information regarding the do and don'ts when using septic system be posted on the website. Ms. Neibart noted that Chester Township passed the DPW Shared Services resolution.

Mr. Monaghan noted that the Board of Adjustment approved an extension of the period to commence construction at the Pitney Property.

The Township Committee had a discussion on the budget process.

OPEN TO THE PUBLIC

Mr. Diegnan made a motion to open the meeting to the public. Ms. Duarte seconded. All members present voted to open the meeting to the public.

Larry Corsi – 323 Mendham Road West – Mr. Corsi suggested contacting the New Providence's Recreation Department, who are self-funded, for recreation ideas.

Ryan Guthrie -23 Cold Hill Road - Ms. Guthrie praised the first responders for their quick response and professionalism when they responded to an emergency situation at his home. He suggested appointing Richard Brusco, if a vacancy becomes available on the Board of Adjustment. He wanted to know the direction for Police Shared Services. Mayor Gisser noted that there are many options to be considered and they are not ruling anything out on direction of the police department.

Mr. Monaghan made a motion to close the public comment section. Ms. Neibart seconded. All members present voted to close the public comment section.

The Township Committee convened into Executive Session at 8:45PM.
