# **STATEMENT OF ADEQUATE NOTICE**

MORRIS COUNTY OFFICE OF HEALTH MANAGEMENT - Stephanie Gorman, Assistant Health Officer

• Coronavirus Update - Ms. Gorman assured the residents that they are working closely with the state health department and local partners to monitor and prepare. She noted that as of 6:00 PM this evening, Governor Murphy issued a State of Emergency which gives state authorities executive powers and safeguard for preparedness in response to the COVID-19 virus. This will allocate specific funding and resources to local health agencies and healthcare systems for their needs. Ms. Gorman provided additional information on the number of cases/deaths from the virus, funding, and testing availability. She also commented on the reasonable precautions that should be taken and the testing protocols.

# Motion to open public comment was moved by Ms. Duarte and seconded by Mr. Orlins. All members present voted to open the meeting to the public.

Bruce Flitcroft – 23 Tingley Road - mentioned that the average homeowner in the United States pays \$3,498 in property taxes. He noted that New Jersey is the highest state in the country where we pay \$10,507 on average, almost three times the national average. Morris County is the 9<sup>th</sup> highest in the United Sates for property taxes, Mendham Township is the 2<sup>nd</sup> highest in Morris County and 12<sup>th</sup> in the State of New Jersey. In Mendham Township residents pay \$19,195 in property taxes which is about 6 times the national average. He expressed that at some point the services and the capabilities of towns in places like Morris County & Bergen County are not that much different than they are in the rest of the county. He expressed that there has to be a longer-term strategy in the town to address the outlier effect.

Jack Curtis – Michael Road – he expressed that the problem is that New Jersey is the #1 donor state in the United States. He explained that every year New Jersey sends a dollar in taxes to Washington and New Jersey receives \$0.61 back and New Jersey has been 50<sup>th</sup> in what we get back. He suggested that the Township Committee should send a letter to the local representatives and ask that they look into the issue.

Ms. Bonanno commented that Mendham Township, in addition to the farmland assessments, has exempt properties that make of 25% of the Township.

Sam Barsa – 20 Conifer Road – He expressed that the problem is the expenses of the town; the Township Committee keeps spending money. He noted that in the last 20 years the budget increased by 400% and the population only increased by 400 residents. He asked for zero based budgets and asked the Township to stop spending money.
