# **COVID-19 UPDATE**

Mayor Neibart provided the following update:

- 346 new cases in New Jersey / 190,021 total cases in New Jersey
- 5 additional deaths in New Jersey / 14,124 total deaths in New Jersey
- Mendham Township currently has a count of 45 cases.

## **ANNOUNCEMENTS**

Mayor Neibart commented that tomorrow, August 26th is the 100th Anniversary of adopting the 19th Amendment, and it is also known as Women's Equality Day.

Mr. Monaghan made several election day reminders.

Ms. Duarte made several safety announcements around the schools reopening and setting a 9 PM Routine. She also announced the upcoming event in celebration of Women's Equality Day and recreation events.

Mr. Orlins commented on the Mendham Township Middle School's report card, which earned a perfect score on the New Jersey Department of Education. The report card is based on absenteeism, standardized test scores, and student projects. He also provided an update on the feedback he received regarding the DPW outsourcing.

## **OPEN TO THE PUBLIC**

Mr. Baio moved. Ms. Duarte seconded the motion to open the meeting to the public.

Michael Broderic - Teamster Representative for the Department of Public Works (DPW) -Appeared at the meeting to discuss the privatization issue of the DPW's work. His concern is with replacing some or all of the members of the DPW. Mr. Broderic provided several reasons why the privatization of DPW is not a good idea. In closing, he requested the Township Committee to place their trust in the way things are handled by the DPW employees, its management staff. He noted that once you entertain the privatization movement, it will raise its ugly head and negatively affect the township and its residents, who require and deserve services they have become accustomed to.

# **OPEN TO THE PUBLIC**

Ms. Duarte moved. Mr. Monaghan seconded the motion to open the meeting to the public.

Jack Curtis - 4 Michael Road — Asked what topics are discussed at closed (private) finance committee meetings. Mayor Neibart addressed his question noting that the topic on DPW was around Request for Proposals (RFP) and bidding. The topic was discussed in public dating back to March.

Mr. Monaghan moved. Mr. Orlins seconded the motion to close the meeting to the public.

## **DISCUSSION**

#### **Administration**

Robert Casey responded to Mr. Curtis' previous comments regarding the catch basin repairs by clarifying the Tilcon's contract.

## Rezoning Request

The Township Committee received several rezoning requests. Mr. Casey suggested that the appropriate action for the Township Committee, since the request came directly to the committee, is to refer those requests to the Planning Board for advice and consent. The Township Committee agreed.

#### Report on August Tax Collection

Tax collection for the third quarter, Total year to date bill out was \$30,800,000, Collected to date is \$30,002,000, Short on collection by \$700,095. At this point, your reserve of uncollected taxes is more than a million dollars. If, in fact, by the end of the year, your total bill out is a little over \$41,000,000, and if we collect \$40,000,000, then we have a \$1,000,000 worth of reserve, you do not have a cash deficit to carry forward. However, you will not generate excess property tax collections, which is the most significant part of your surplus for the last five years. You are currently on a path that should mean that you will end up the year in the black. However, you will have a hole in 2021 of about \$500,000, which you usually have a surplus from excess tax collection the prior year.

## Report on Facilities – Town Hall Construction Project

At the last meeting, the architects presented a plan for the Town Hall Construction Project. Overall, the Township Committee's consensus was that an \$8 million project exceeded their estimates on what a new building would cost.

Mr. Casey notified the architects that the \$8 million project was unrealistic and could they bring it down to \$6 million which Mr. Casey's recommendations.

Mr. Casey provided a fiscal analysis and the impact a \$6 million bond ordinance for the town hall repairs and new construction would have on the taxpayers.

Mr. Casey painted a big picture for the Township Committee and public with the following process

## STEP ONE: START WITH TOWN HALL BUILDING

- Stabilize the outside of the building
- Fix the roof
- Fix the rotted soffits
- Replace the windows
- Fix the stucco
- Clean-up the outside of the building

# STEP TWO: LIBRARY

• Build a Library – Bid out/hire a contractor

## **STEP THREE: POLICE DEPARTMENT**

Relocate Police Department to the first floor

# FINAL STEP: RECREATION FACILITY

Current police department building is vacated and converted into a Recreation Facility (Administrative Offices on the top floor / open space on the middle area)

The architects have expressed that need a scope and budget for the project.

Mr. Orlins asked for a plan with the right requirements for the police department.

Mr. Monaghan made the following suggestions:

- Keep the library in the first floor of Town Hall,
- Make repairs to the Town Hall
- House the Police Department in the building next door to Town Hall

Ms. Duarte is concerned with the project's cost to taxpayers but expressed that action needs to be taken. Her position has always been to maintain the library, and she also mentioned using the current police headquarter for the recreation facility. A recreation center has also been on her wish list. She would like to hear input from the public. She is in favor of reusing adaptive reuse of Town Hall. She expressed that it makes more sense to have a stand-alone library and integrate Town Hall with the police station.

Mr. Baio made the following comments:

- The Police Building that Mayor Gisser presented would have never been built for \$2.5 million
- Mayor Neibart's initiative to getting a comprehensive plan is what different from past plans
- If we qualify for a state grant, we get to buy a library at 50% off. If the opportunity, then he is not on board
- The issue is, how do we improve property value in town?
- Adaptive Reuse is cool
- The mechanical system can be beneficial
- Sell the police station after it is habituated and use the profit as a way of paying down debt.

Mr. Orlins also agrees with Mr. Baio's suggestions and also noted that library grant can be utilized for repairs on their existing building. The grant is not necessarily for new construction.

Mayor Neibart noted that three options that would be presented to Cornerstone for their expertise:

## 1<sup>st</sup> OPTION

- \*Re-fit Town Hall
- \*Fix the roof
- \*Fix the widows
- \*Fix the sides of the building
- \*Fix the vertical circulation problem one or two towers
- \*Gut the bottom floor of town hall
- \*Move the Police Department into the bottom floor of town hall
- \*Build a new library next door

## 2<sup>nd</sup> OPTION

\*Expand Town Hall to fit all three departments (Administrative offices, Police Department and Library) in Town Hall

## 3<sup>RD</sup> OPTION

- \*Fix the roof
- \*Fix the roof
- \*Fix the widows
- \*Fix the sides of the building
- \*Fix the vertical circulation problem one tower
- \*ADA complaint building (possible HVAC)
- \*Build a new Police Department next door

# Liaison Reports

- Construction (Monaghan) No update
- Communications Committee, Marketing (Duarte) Met last week to discuss different marketing
  ideas, tag lines, logos, website. Looking at what other communities have done to market their
  towns. Hoping to have the committee come in October with some sort of a report and
  recommendations.
- **Department of Public Works** (**Monaghan**) Paving has started, several roads are being milled, prior to paving. Brush pick up from the last storm started yesterday and will continue throughout town.
- Environmental Commission (Duarte) Meadow Wood Hike pushed off to September 20th.
- **Health Department** Had a meeting last night, normal business. Looking to put yard signs or banner in town to remind people about COVID and how to protect themselves. Also, discussed the flu clinic.
- Finance Committee (Orlins / Neibart) No update report provided earlier on in the meeting
- *Fire Department (Neibart)* Run cards are complete. Brookside Engine Company #1 will host their Annual Clam Bake-take out.
- *First Aid Squad (Duarte)* Call volumes are starting to get back up to normal. Looking to recruit new members.
- Historic Preservation (Baio) No update
- *Library (Monaghan)* Business has been steady about 863 visits. They hosted their Book Recycling Program.
- **Mendham Sewer East & West (Neibart)** The third-party Engineer is looking for additional information from the residents. Will be asking the residents to mark their laterals with flags.
- **Mendham Township School District (Orlins)** commented that the Mendham Township School systems are #1 in the state.

- Mendham TV (Duarte) No update
- Planning Board (Baio /Monaghan) No Update
- **Police** (**Duarte**) Buttermilk Falls has quieted down a little bit. Officers turned away 25-30 cars on the weekend. There is increase usage during the week.
- **Pitney Park (Monaghan)** Meetings were held around the wall garden. Final plans for bidding are being completed right now and we will be ready to submit to the state for final review before it goes out to bid.
- **Recreation Committee (Orlins)** Ralston Field looks fantastic. David is going to give a report at the next meeting on Brookside Beach and where it ended up for the season.
- Regional School District (Monaghan) No update
- **Shared Court (Neibart)** Court Administrator is retiring. Chester Township is handling the interview process.
- **Stigma-Free Initiative (Duarte)** Working to organize a webinar around Suicide Prevention Awareness Month. She will have more information at the next meeting.
- Surrounding Town Outreach (Orlins) No update
- Tax Assessor (Neibart) No update
- *Tree Committee* (*Neibart*) Hosting an Office of Emergency Management post storm meeting regarding power lines and the trees.
- Wildlife Management (Duarte) The state archery season for deer begins on September 12<sup>th</sup> and that signs will be posted on the entrance of our parks.
- **Zoning Board** (**Baio**) The state has passed legislation requiring municipalities to extend zoning board approval similar in act like they did in 2008. Approval Extension Act took effect last week. It was proposed in March signed in July.
