#### **ANNOUNCEMENTS**

Mr. Monaghan, Ms. Duarte, Mr. Baio and Mayor Neibart announced upcoming township events and thanked all those involved in the participation of the July 4<sup>th</sup> celebrations.

#### **COVID – 19 UPDATE**

Mayor Neibart provided an update on the Covid-19 pandemic, noting that 10 million vaccine doses have been administered in the state thus far and the county mega-site will close soon.

#### **OPEN TO THE PUBLIC**

# Ms. Duarte made a motion to open the meeting to the public; Seconded by Mr. Orlins.

Maria Moore – 26 Ironia Road – Ms. Moore expressed her objection to the opening of the tasting bar and brewery next to her property at Backer farm and her concerns for her family's safety from customers driving after drinking.

Bernadette Koenig – Northgate Rd - Ms. Koening posed these questions: whether single stream recycling is still the norm; if the committee responded to the Morris County farmland preservation questionnaire; how noise ordinances are enforced; whether July 1<sup>st</sup> Planning Board meeting notes are available to the public.

Peter Banos – 47 Ironia Rd., Mendham Boro - Mr. Banos read a letter that will be published in the Observer Tribune that outlines his objections and concerns regarding what he considers the negative impact that the tasting bar will have on the community.

Diana Orban-Brown – Ironia Road – Ms. Orban Brown expressed her support for the Backer farm brewery, with reservations. She said she will explain her reasoning at the Planning Board meeting in August, and that she felt the Backers should be given an opportunity for consideration.

# Mr. Orlins made a motion to close the meeting to the public; Seconded by Ms. Duarte.

Mayor Neibart responded to questions raised in the open forum.

- Regarding single vs dual streaming- the only time single stream will occur is the week after a holiday. Dual streaming is the norm for the township.
- The township responded to the agriculture questionnaire and will be made available to the public on the website.
- The police chief is the first point of contact for noise complaints. The township is looking into decibel readers.
- Enforcement measures are handled by the police and as new developments occur the chief will
  discuss with the administrator and governing body with respect to zoning, traffic issues. Mr.
  Orlins added that Oak Knoll residents put together some materials indicating requirements that
  the Planning Board may be able to include with respect to enforcement.

There was a discussion on access to the Planning Boards recordings; and it was suggested that anyone interested in Planning Board videos should contact the Planning Board secretary. Mr. Baio commented that the Morris County Agricultural Board has a presence in the Backer Farm.

Mayor Neibart suggested that the committee look into how it works with the Planning and Zoning Boards. If this particular application rises above a farm description and is deemed a business, then the committee should consider creating commercial business ordinances.

Mayor Neibart asked that the land use resolutions be tabled to the next meeting. Ms. Duarte explained that Morris Township passed a package of land use resolutions that have to do more with the redevelopment process which comes to the Township Committee, not the Planning Board. It was determined that the Planning Board would be asked for their input on the resolutions.

# OPEN TO THE PUBLIC

Ms. Duarte made a motion to open the meeting to the public; Seconded by Mr. Orlins.

Maria Moore – 26 Ironia Road – Ms. Moore asked for the Planning Board recording but was told that the recording was not working.

Peter Banos – Ironia Road – Mr. Banos commented on notes from a report from H2M consultants regarding agriculture uses and public and private nuisance.

Mr. Orlins made a motion to close the meeting to the public; Seconded by Ms. Duarte.

# **DISCUSSION**

**Construction Project Update** - Mr. Casey reported that with respect to the police building, issues with the Department of Corrections and DEP are resolved. Full plans are available electronically as of tomorrow and bids are out. Town Hall building issues in reference to the windows are resolved. The goal is to put out a winter bid with a start date in May. There was discussion amongst committee members regarding the cost of the project, whether alternates would be necessary and the expectation is that the project would be within budget.

**Pitney Park** - Mr. Monaghan reported that the project is moving at a record pace. He shared a letter from Mr. Sletteland, to the Pitney Park team, proposing an architect be hired to create drawings for a museum to be built on the property. Mr. Monaghan voiced his objections with a building on the site because the site (park) is specifically intended to be low maintenance; some suggestions were to donate the artifacts to the Morristown Library, or house them in the township library or town hall. It was decided that the Historic Preservation Committee would be brought into the conversation.

Motion to adjourn at 8:39 PM made by Ms. Duarte; seconded by Mr. Orlins.
