He noted that the Eagle Scout project for installing a new kiosk is complete at Dismal Harmony. He announced the upcoming Styrofoam Collection Day which will take place on June 11th. Mr. Slayne followed up on a request to have DPW assist with installing five new signs.

George Koenig - 13 North Gate Road — He expressed that many residents are asking him if the committee is for residential or business development with the exception of traditional farm stands; he noted that this would be a hot topic during elections. He mentioned that based on all the surveys that the committee has received, let's keep Mendham as exceptional as it possibly could be. He noted that those who preceded the committee erred on being conservative — residential, not business. He asked the committee to think about the bigger and longer picture when thinking about agrotourism.

Peter Banos – 47 Ironia Road, Mendham Borough – Mr. Banos spoke on the environmental concerns with the Backer Brewery application. He asked the committee for their support with the group's public health and safety concerns.

Auditor Kathi Mantell commented on the township's audit noting that the township is in very good financial shape.

OPEN TO THE PUBLIC

Diana Orban Brown – Ironia Road – Ms. Brown commented on Ordinance 09-2022, noting an item for a light study at Mosle Field to accommodate the proposed turf field; she asked that there needs to be a discussion before money is spent.

Mary Michailidis – 10 Thackery Lane – Ms. Michalidis commented on the DPW staffing levels and outsourcing the township's landscaping needs, noting that contractual-based landscapers will not be available to service Mendham's needs during emergencies. She also stated that there is much work to be completed in the township, so reducing DPW staffing is not appropriate. Finally, she asked if there was any policing of issued construction or tree permits.

Patricia Zimmerman – 3 West Main Street – Congratulated the Mayor for allowing the "give and take" during open to the public.

George Koenig – 13 North Gate Road – Given the size, intensity, and the unknowns of all the possible types of events and multiple day events allowed, he believes and asked that the committee continue to keep residential Mendham as residential as possible; And to vet the project as much as possible and declare this a major development.

Martin Slayne – Indian Hollow Road – Mr. Slayne noted that several residents have inquired about the status of the Hillandale Development, questioning the removal of trees and road development. Mayor Monaghan pointed out that the road is complete, at least to the base course where it needs to be, and the tree removal is legitimate.

Mary Michailidis – 10 Thackery Lane – Ms. Michailidis asked for clarification on the fines when property owners remove trees without permits.

Tracey Moreen – 52 Hardscrabble Road – Ms. Moreen suggested that we reinvigorate or refresh the idea around the Tree Committee, making it more of a dialogue because it means so much to so many residents. She mentioned that Jersey Central Power & Light (JCP&L) remove trees every few years, noting that they asked to remove five trees on Corey Lane two years ago, and now they are asking for seven more trees. She looked at the seven trees, and there was only one dead and two near the lines, so there were four trees that didn't require removal; she believes JCP&L might be a bit aggressive with tree removal, and the removal of trees goes against the Master Plan.

Motion to close public comments made by Ms. Duarte; Second by Mr. Orlins. All member voted by voice call in favor of closing the public comment section.

Mayor Monaghan noted that as a part of the budget the committee put money aside for a Forester so that we can put together a Forestry Management Plan for the township.

DISCUSSION

Department of Public Works

The township committee engaged in a discussion about having a study completed (peer review) on the staffing levels and tasks within the public works department. The committee also discussed the criteria for selecting an individual to complete the review. The discussion determined that the committee favored a peer review of the public works department.

Tree Concerns

There was a discussion on how to inform new residents about the tree removal permit process; Ms. Duarte made a suggestion to send a letter notifying residents of the process. The committee agreed to include a notice in the tax bills.

EXECUTIVE SESSION

Motion to entered into Executive Session at 8:59 pm made by Ms. Duarte; Seconded by Mr. Orlins. All members present voted in favor.

ORDINANCE NO. 08-2022 TOWNSHIP OF MENDHAM COUNTY OF MORRIS COUNTY, STATE OF NEW JERSEY

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM AMENDING SUBSECTION 10-48: THE MENDHAM EAST AND WEST WATER POLLUTION CONTROL SYSTEM ADVISORY COMMITTEE

WHEREAS; Ordinance 04-2021, adopted on March 22, 2021, established in the Township of Mendham a Mendham East and West Water Pollution Control System Advisory Committee; and

WHEREAS; the members of the Advisory Committee shall be appointed by the Township Committee and shall include *nine* members, consisting of Class 1 and Class 2 members; and

WHEREAS, Class 2 members consist of the mayor (or designee); the Township Committee Sewer East and West *Liaison*; the Township Administrator, and the Township Chief Financial Officer; and

WHEREAS, the Township Committee has determined that its necessary to amend the Class 2 membership to consist of the mayor (or designee); the Township Committee Sewer East and West *Liaisons*; the Township Administrator, and the Township Chief Financial Officer.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Township Committee of the Township of Mendham, the County of Morris, State of New Jersey that the Class 2-membership, shall include the mayor (or designee); the Township Committee Sewer East and West Liaisons, the Township Administrator, and the Township Chief Financial Officer.

BE IT FURTHER RESOLVED that the nine-member advisory committee shall be amended to include *ten members*, consisting of Class 1 and Class 2 members.

that would work to the benefit of the Township - this does NOT include increasing the tax base as the major goal.

There is another way to increase the tax income without increasing supporting services, such as additional roads, increase in student population, etc.

I suggest that our present zoning be changed in order to allow homeowners to put an addition on their existing home or add a small cottage to their property.

This approach solves new world that more and more families are being faced with. For example, increasingly we find families are becoming responsible for caring for elderly parents or, at the other end of the spectrum, sons and daughters recently finished schooling who cannot afford to live separately. Among my own friends, I find that as some become infirmed, they are hiring live-in "aids" to help out, making it possible for them to stay in their homes and avoid going into "assisted living".

Of course, these additions would have to comply with zoning requirements, as for example:

Set backs Limits on size - presumedly limiting to one bedroom Etc

These properties would increase in value, taxes would go up. Yet, as i said before, no new roads, and few, if any, additional school age children. AND we would keep and protect, what makes our Township unique, OPEN SPACE.

I see this as a WIN-WIN for the Township and for our residents.

Please consider this when you are looking at the Master Plan.
