PRESENTATION

New Jersey Highlands Council – Mr. Corey Piasecki presented a PowerPoint presentation titled "Partnering with the New Jersey Highlands Council." Mr. Benjamin Spinelli, Executive Director, was also in attendance and assisted Mr. Piasecki with the presentation. Presentation attached.

Recreation – Mosle Field – Site Feasibility Study - David Guida, Recreation Director, presented the study to the committee. The committee engaged in a discussion.

ANNOUNCEMENTS

The committee provided their announcements on upcoming events in the township.

OPEN TO THE PUBLIC

Martin Slayne, Indian Hollow Road – Mr. Slayne expressed his appreciation for the presentation by the Highlands Council, noting that it ties in nicely with some of the recent discussions about getting a conservation strategy together for the community. He also congratulated David Guida on an excellent presentation for the recreation facility; he added that some historic dumping grounds in the Mosle area might be a safety concern and asked for a review of the dumping site. Finally, he commented on and clarified the Environmental Commission's mandate.

Todd Christie, Talls Oak Court – Mr. Christie expressed concerns about the safety of Mosle Field, the parking lot, and safety at night because there is no lighting. He noted that safety is a big focus of their Twin Boro Football organization. He expressed his support for Ordinance 14-2022.

Sam Barsa, Conifer Drive – Mr. Barsa does not support partnering with the Highlands Council due to the excessive bureaucracy of the organization.

Randy Lee, Oak Knoll Road – Mr. Lee is the Head of the Fields and Equipment for Twin Boro Football, so he deals with the old, outdated portable light systems and the field's maintenance. Mr. Lee mentioned the safety concerns of the field and expressed they want to take the lead to make Mosle Field a first-class facility. He expressed his support for Ordinance 14-2022.

George Koenig, North Gate Road – Mr. Koenig thanked Mr. Slayne for clarifying the Environmental Commission mandate, but he did not like how the comments moved toward a political statement. Finally, Mr. Koenig commented on the Highland Council. He noted that partnering with the council is a huge decision for the town to go from the planning to the preservation area, noting that the devil is in the details.

Mary Michailidis, Thackery Lane – Ms. Michailidis asked for clarification on the Mosle Field discussion.

Matt VanKirk, Horizon Drive – Mr. VanKirk reminded the public that trail issues should be sent to the Environmental Commission via the township's website for their review.

Bernadette Koenig, North Gate Road – Ms. Koenig expressed that it makes sense for the committee to listen to what the New Jersey Highland Council has to say and hopes the committee will move forward with the initial assessment offered by the council.

Tracey Moreen, Hardscrabble Road – Ms. Moreen commented that aesthetics for lights at Mosle Field is a no-brainer and supports Ordinance 14-2022. She brought to the committee's attention that the township is currently out of compliance with the tree ordinance. She noted that we do not have a tree conservation officer, and there are other points to note to bring the ordinance into modern 2022.

Diana Orban Brown, Ironia Road – Ms. Brown commented on the artificial turf that has suddenly appeared at the Mosle Preserve.; noting that no one seems to know where it came from or its use. Ms. Brown believes the township is getting ahead of their selves and a lot of investigation has to go into anything we are doing on preserve land (Mosle).

Mr. Orlins made a motion to close the open to the public session; Seconded by Ms. Neibart. Voice Vote: All members present voted in favor.

ORDINANCE 14-2022

ORDINANCE APPROPRIATING \$20,000 FROM THE CAPITAL IMPROVEMENT FUND IN ORDER TO PROVIDE FOR A STUDY OF IMPROVEMENTS TO MOSLE FIELDS AND BY THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY AS FOLLOWS:

Section 1. \$20,000 from the Capital Improvement Fund is hereby appropriated to provide for a study of Mosle Fields to assess the feasibility and costs of lights at Mosle Fields and to review the playing surfaces of the existing fields at Mosle Fields, in the Township of Mendham, in the County of Morris, New Jersey (the "Township").

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law.

TOWNSHIP OF MENDHAM MORRIS COUNTY, STATE OF NEW JERSEY

ORDINANCE 13-2022

ORDINANCE APPROPRIATING \$52,000 FROM THE CAPITAL IMPROVEMENT FUND IN ORDER TO PROVIDE FOR FIRE DEPARTMENT EQUIPMENT AND TOOLS IN AND BY THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY AS FOLLOWS:

Section 1. \$52,000 from the Capital Improvement Fund is hereby appropriated to provide for acquisition of Fire Department equipment and tools, including turnout gear, and major repair of fire apparatus, in the Township of Mendham, in the County of Morris, New Jersey (the "Township").

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law.






The New Jersey Highlands Water Protection and Planning Act: "...the protection of the New Jersey Highlands, because of its vital link to the future of the State's drinking water supplies and other key natural resources, is an issue of State level importance that cannot be left to the uncoordinated land use decisions of 88 municipalities, seven counties, and a myriad of private landowners..."

Since watersheds and other natural resources do not follow municipal boundaries, a regional planning approach is required to protect them.





Regional Planning

- Highlands Act directed a regional approach to land use planning.
- Since watersheds and other natural resources do not follow municipal boundaries, a regional planning approach is required to protect them.
- Other examples of regional planning in NJ
 - Hackensack Meadowlands Commission and Master Plan
 - Pinelands Commission and Comprehensive Management Plan




Regional Master Plan (RMP)

The RMP is structured around the following planning considerations:

- Natural Resources
- Water Resources
- Agricultural Resources
- Historic, Cultural, Archaeological, and Scenic Resources
- Transportation
- Landowner Equity
- Sustainable Economic Development
- Air Quality

For each of these areas, the RMP provides a regional analysis, identifies Goals, Policies, and Objectives (GPOs) and defines programs to implement the GPOs.



Highlands Council

Highlands Council Grant Program

Established by the Highlands Act to pay for the "reasonable expenses" associated with implementation of the Act

- Reimbursement based
- No match required
- Eligible applicants: Highlands municipal and county governments
- Eligible expenses: planning, design and engineering costs
- Requires Highlands Council staff approved Scope of Work

Why work with the Highlands Council?

- Advance municipal planning vision
- Direct growth to areas most appropriate for growth
- Protect and enhance open spaces and natural resources
- Address transportation challenges
- Improve stormwater management (reduce flooding)

Collaborative process, driven by municipal needs.

Mendham Township's goals are also Highlands Council goals.



RMP Considerations for Mendham Township

- Entire Township in Planning Area of Highlands Region; working with Highlands Council is voluntary.
- Revisions to land use and resource management planning documents as appropriate to align with the Act and RMP
- Township retains all local enforcement and regulatory control.

Goal is resource protection and sustainable growth through good planning.



Affordable Housing Considerations

- Highlands Act requires the Regional Master Plan be taken into consideration when determining fair share housing needs.
- Municipalities need to adopt a housing element and fair share plan.
- Highlands Council grant funding:
 - Development of Housing Element and Fair Share Plans
 - Build out analysis to inform vacant land and durational adjustments
 - Mid-point reviews



Potential Next Steps

- Initial Assessment (IA) Report
- Grant funds to complete IA Report
- No obligation to proceed beyond
- Continue conversation according to Township's wishes





Mendham Township Mosle Field – Site Feasibility Study

Mendham Township Recreation

Presented to Mendham Township Committee October 24, 2022

Primary Goal:

Coordinate Mendham Township and youth sport programs for improved recreational facilities to support local year-round sports programs for residents and neighboring towns.

Shared goal from Mendham Recreation Advisory Committee, Twin Boro Bears, Mendham Chester Baseball/Softball, West Morris Soccer Club and Chester Mendham Lacrosse

Request to Mendham Township Committee

The Mendham Township Recreation Advisory Committee and local youth sports programs request feasibility study to improve Mosle Field recreational facility for year-round sports programs.

History

- 2021 Budget Development: Discussions begin at Board Level and with sports clubs surrounding needs
- February 2022: Meeting with Local Sports organizations with request for Turf/Lights in Township
- March 2022: Budget Proposal for Feasibility Study on lights to accommodate potential future turf.
- Pause on plans due to possible plans in other local municipalities
- September 2022: Meeting with sports leagues expressing the desire to move forward with plans at Mosle
 - Subsequent individual meeting/calls with all local sports organizations to gather list of needs for project
- October 2022: Proposal brought to Recreation Committee with additional details added

Site Selection

- Mosle Field was selected as the most appropriate filed in the Township to explore
- India Brook Currently one soccer field and has irrigation issues
- Brookside Field Township does not own, currently only baseball fields
- Wysong/Meadowood/Mount Pleasant Do not have an appropriate footprint for development for multiple sports usage
- Ralston Most likely second choice for development as it is a central location. However, existing parking issues and neighborhood

Mosle Site Selection – Concerns & Advantages

Traffic Increase to Neighborhood

When considering moving forward with any plan, we will need to also consider a traffic study

Contract Lights

Portable lights are currently used there already, there is a degree of familiarity in neighborhood

Current Footprint

 Footprint is ripe for development. Currently has ample parking, a baseball/softball field, soccer/lacrosse field and a football field

Mosle Master Plan at time of purchase

There is the possibility to use Green Acres funds for development

Sports Leagues

- Field Usage by League in Mendham Township
 - Baseball and Softball Spring, Summer and Fall
 - Football Summer and Fall
 - Lacrosse Spring and Summer
 - Soccer Spring Summer and Fall

By The Numbers:

Twin Boro Bears - 252 Football & 143 Cheer

Chester Mendham Baseball and Softball – 424 Baseball & 156 Softball

Chester Mendham Lacrosse – 193 Boys LAX & 225 Girls LAX

West Morris Soccer Club – 230 (Spring) & 486 (Fall)

Sports Leagues/Rec Committee Requests

- Current Obstacles highlighted by Sports Leagues
 - Limited Youth recreational facilities and fields
 - Zero lighted youth recreation facilities
 - O Zero sanctioned football fields in Mendham Township that can be used for games
- O Baseball field would need to be repositioned to be usable at sundown
- Currently there are existing safety concerns in the parking lot, need parking lighting and lot flow development
 - Includes the handicap access road safety concerns
- Park of the plan should look at irrigation upgrades to the fields.
- O If we are developing this site, we should also be looking at the past ideas that have been brought to the Recreation Committee basketball court and dog park

All stake holders do agree that lights are the top priority

2022 Budget Request

- Ordinance 09-2022 Approved:
- Recreation improvements consisting of the major repair or replacement of fencing and other improvements at Brookside Beach, acquisition and installation of park furnishings, improvement of pickleball/tennis courts at Mt. Pleasant Park and a lighting study for Mosle Field to accommodate the proposed turf field

Study Focus

The main goal of the project is to increase the usability and safety of Mosle Field

- PRIORITY #1: This feasibility study's focus is going to be on lighting the baseball and football fields at Mosle
- PRIORITY #2: Explore necessary upgrades (seeding, rolling, irrigation) that need to be made so that IF lights are installed that the fields maximize on use
- PRIORITY #3: Repositioning of the baseball field to make it playable at sundown

Where are we now?

Study for feasibility at Mosle Field to include

- 1. First determination that must be made is:
 - O Can we have three independent fields at the complex, or is there only space for two
- 2. Once this determination is made, French & Perello can complete a Site Assessment and Feasibility Study of lights
 - Field Lights
 - Parking Lot Lights
 - Landscape work that needs to be done on the existing fields

Recommendations of additional items to study from stakeholders:

b) Lights and Turf **or** (c) Lights and Turf, along with exploring the possibility to develop site plan with other amenities which may include a dog park, basketball courts, batting cages, etc.

Future Timeline

- November-January Completion of Site Assessment
- January/February Presentation of Site Assessment to Township Committee
- February/March Development of Site Concept Plan (should approval be given)
- March/April Inclusion of Site Concept Plan in Budget Proposal to go to Township Committee and Finance Committee

IF APPROVED IN BUDGET:

- May/June/July (dependent on budget adoption) bid project
- Possible construction in July/August/September for fall completion

Other Items of Note

- During discussions, should lights and turf be installed, the idea of rental or field user fees will be explored and all sports leagues are amenable
 - This will create a fund that will be able to have funds set aside for future light and/or turf replacements or repairs
 - If lights, will likely only be able to charge a rental fee for groups at night
 - O If lights and turf, field user fees be more attainable
