Mayor Monaghan led the assembled in the Pledge of Allegiance.

PROCLAMATION

Proclamation to Maria Coppinger, Township Clerk

Mayor Monaghan and the Township Committee presented a proclamation to Maria Coppinger, Township Clerk, for her service to the Mendham Township community.

Mayor Monaghan read the proclamation aloud to all assembled.

Ms. Coppinger thanked the Mayor and Township Committee, as well as the Mendham Township community for the opportunity to serve as Township Clerk. She also welcomed Karen Orgera as she begins her professional service to the community as Acting Township Clerk.

Mayor Monaghan and the Township Committee expressed their appreciation to Ms. Coppinger for her service and provided their well-wishes.

Proclamation to West Morris Mendham High School Coach Roy Hamblen

Mayor Monaghan and the Township Committee presented a proclamation to West Morris Mendham High School Coach Roy Hamblen on his retirement after 34 years of service at the high school and as an accomplished and acclaimed cross-county coach.

Mr. Orlins read the proclamation aloud to all assembled.

Mayor Monaghan and the Township Committee expressed their appreciation to Mr. Hamblen for his 34 years of service to the Mendham Township youth and acknowledged the positive impact he made on the lives of many student athletes.

Mr. Hamblen thanked Mayor Monaghan and the Township Committee for the proclamation and briefly shared a few stories as he reflected on his years of coaching.

All assembled provided their well-wishes to Mr. Hamblen in his future endeavors with many parents and students expressing their personal thanks and appreciation to Mr. Hamblen.

ANNOUNCEMENTS

The Mayor and Township Committee made the following announcements:

Mr. Baio, Deputy Mayor, expressed his thanks to the Mendham Township community for allowing him to have served them on the Township Committee for the past 3 years and further expressed his appreciation for the support he has been receiving following the recount of the November General election recount.

Ms. Neibart wished everyone a warm holiday season and provided a reminder that registration is open for residents interested in participating in the Township's recreation ski program. She further expressed her personal thanks to Ms. Coppinger for her service as Township Clerk.

Ms. Duarte expressed her personal thanks to Mr. Hamblen and Ms. Coppinger for their service to the community. She further provided her well-wishes to Ms. Coppinger in her new home and wished everyone a happy new year.

OPEN TO THE PUBLIC

Mayor Monaghan opened the meeting for public comments and stated that each person would be given two minutes to speak.

Addison O'Donnell, 10 Colonial Road, Mendham NJ commented that he is one of the voters brought into Mr. Baio's lawsuit alleging ineligibility to vote in the November General election in Mendham Township based on his residency at that time. He commented that his family has been Brookside residents for 62 years and confirmed that he currently resides at 10 Colonial Road.

George Koenig, 13 North Gate Road, Mendham NJ participated via Zoom. He thanked Mr. Orlins and Ms. Coppinger for their service to the community and provided his accolades to Mr. Orlins for his work as a member of the Township Committee.

Christine Blood, 32 Tingley Road, Mendham NJ commented that she supports the right of any candidate running for public office to seek a recount of election results and, if necessary, to file a legal proceeding to ensure that all votes were cast by eligible voters. Ms. Blood further commented that the lawsuit filed should proceed to judicially validate the outcome of the election.

John Seravalli, 111 Imperial Drive, participated via Zoom. He commented on the importance that every citizen must vote in the jurisdiction where they reside. He further commented that, regardless of political party, there must be a process to ensure that all votes that were cast in the Mendham Township Committee race are lawful and legal.

Debby Dolche, 46 Essex Drive, Mendham Borough NJ commented that Mr. Baio's lawsuit has drawn national attention and thus may have far-reaching implications nationwide. She further commented that the place where a young person may choose to live after graduating college may not be permanent, which is why some may maintain their hometown address. Ms. Dolche voiced her disappointment that Mr. Baio filed a lawsuit questioning the eligibility of Vote by Mail ballots cast in Mendham Township during the November General election.

Laura Ali, Morris County Republican Committee Chairwoman, participated via Zoom. She commented that the township residents should not be embarrassed by the lawsuit which seeks to validate voter Vote by Mail ballots cast but rather should be concerned that voter fraud may be an issue and ineligible votes should not be counted to ensure fair elections. She encouraged everyone to respect the judicial process as it proceeds in its course.

Matthew Messina, Brockden Drive, Mendham NJ provided his well-wishes to Coach Hamblen. He warned against embracing election conspiracy theories and commented that no one should question how long, or where, a young voter may temporarily living or judge that they may not be eligible to vote using their parents' address.

Peter Staples, 10 Woodland Drive, Brookside NJ participated via Zoom. He commented that Mr. Baio's lawsuit is a sham and offered that efforts should be focused in cleaning up voter registration rolls. He further commented that there is no evidence that Vote by Mail encourages voter fraud.

Carol Terrill, no address was stated, participated via Zoom. She expressed her disappointment in Mr. Baio filing a lawsuit alleging voter fraud and contesting many Vote by Mail ballots that were cast by young voters.

Christine Meyers, 11 Village Road, New Vernon NJ and a former long-time Mendham Township resident thanked Mr. Orlins for his service on the Township Committee. She commented that accounts of voter fraud across our county have led to questioning of the integrity of elections. Ms. Meyers further commented that there is a legal process that may be engaged to audit and validate that all eligible votes cast are counted. Ms. Meyers lastly commented that greater efforts must be made to verify that voter registration rolls are accurate.

Seeing and hearing no one else wishing to be heard, Mayor Monaghan asked for a motion to close public comments.

Motion to close public comment period was made by Ms. Neibart and seconded by Mr. Orlins, with all members present voting in favor, none opposed.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM APPOINTING ACTING MUNICIPAL CLERK AND REGISTRAR OF VITAL STATISTICS

WHEREAS, a vacancy exists in the position of Municipal Clerk and Registrar of Vital Statistics for the Township of Mendham due to the resignation of Maria Coppinger effective December 30, 2022; and

WHEREAS, N.J.S.A. 40A:9-133 requires that every municipality shall have a municipal clerk appointed for a three-year term by the governing body; and

WHEREAS, a vacancy exists in the position of Mendham Township Municipal Clerk and Registrar of Vital Statistics effective December 28, 2022; and

WHEREAS, N.J.S.A. 40A:9-133c. permits the governing body, within 90 days of the occurrence of a vacancy by reason of departure of a registered municipal clerk, to appoint a person who does not hold a registered municipal clerk certificate to act as acting municipal clerk for a period not to exceed one (1) year and commencing on the date of the vacancy; and

WHEREAS, the Mendham Township Committee desires to appoint Karen Orgera as Acting Municipal Clerk and Registrar of Vital Statistics for a term of one (1) year commencing on December 28, 2022.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mendham, in the County of Morris, State of New Jersey, as follows:

- 1. Karen Orgera is hereby appointed to the position of Acting Municipal Clerk and Registrar of Vital Statistics of Mendham Township for a term of one (1) year commencing on December 28, 2022 and terminating on December 28, 2023, unless, at the option of the Township Committee, such person is either reappointed as set forth herein, or obtains a registered municipal clerk certificate and is appointed as the Municipal Clerk.
- 2. Karen Orgera, as Acting Municipal Clerk, shall perform all of the duties of the Township Clerk as set forth in N.J.S.A. 40A:9-133 and be compensated for the position in the amount of \$65,000. At the option of the Mendham Township Committee and with the approval of the Division of Local Government Services, be reappointed as Acting Municipal Clerk for a maximum of two subsequent one-year terms following the termination of the temporary appointment.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12

WHEREAS, the Township Committee of the Township of Mendham is subject to certain requirements of the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-6, <u>et seq.</u>; and

WHEREAS, the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Township Committee of the Township of Mendham to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

(1) Matters Required by Law to be Confidential: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.
(2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.
(3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
(4) Matters Relating to Collective Bargaining Agreements: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
(5) Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.
(6) Matters Relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.
(7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege: Any pending or anticipated litigation or contract negotiation in which the public body is, or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.

(8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose right could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
