"Thank you all for coming to, or attending virtually, the 2023 Township Committee Reorganization Meeting. Public participation in your government is a hallmark of democracy, and I am especially proud to be a leader of this municipality that we all love so much.

"Thank you and welcome to our two newest members, Tracey Moreen and Lauren Spirig. I feel fortunate to have had the opportunity to get to know each of you over the past months, and look forward to working with you on behalf of our great community. I believe that there is much that we will all align on, and work collaboratively on for the common good. I also think it is safe to say that we will not agree on everything. That's ok. OPEN TO THE PUBLIC

Mayor Monaghan opened the meeting for public comments.

Matthew Messina, 10 Brockden, Mendham NJ provided his congratulations to the two newly-elected members on the Mendham Township Committee. Mr. Messina voiced his disappointment that Committeewoman Duarte was not voted on to be Mayor or Deputy Mayor.

Martin Slayne, Indian Hollow Road, Mendham NJ provided his congratulations to the two newly elected members on the Mendham Township Committee and encouraged more bipartisan appointments be made on Township boards and committees.

Emily Hourihan, 47 Corey Lane, Mendham NJ inquired why an invocation was given at the beginning of the Reorganization meeting by a clergyman of the Catholic faith and suggested that the Township Committee should consider including opening prayers by other houses of worship and religious faiths.

Seeing and hearing no one wishing to be heard, Mayor Monaghan asked for a motion to close public comments.

Motion to close public comment period was made by Ms. Neibart and seconded by Ms. Spirig, with all members present voting in favor, no one opposed.

Ms. Duarte sought a point of order. She suggested that invocations given at the Township Committee Reorganization meetings should be rotated to include different houses of worship and religious faiths. She further commented that she recently attended a Reorganization meeting in another town where a lengthy statement was read prior to entering into public comments. The statement provided clear guidance to the public on how they should address their comments and suggested a similar protocol be used and incorporated in the agenda when entering into public comments.

Mayor Monaghan clarified that Father Mike Drury serves as the Chaplin for many Township organizations and stated he was asked to invite Father Mike to provide the invocation at the Township Committee Reorganization Meeting. He also clarified that asking members of the public to direct their comments to the mayor or presiding officers is not a new rule but rather the protocol that has traditionally been adopted by the Mendham Township Committee, as well as by many other municipality's governing bodies. Mayor Monaghan offered that he would prepare a statement to be read before entering into public comments but preferred not to have to establish rules for public comment.

Ms. Duarte offered to draft a statement for inclusion on the meeting agenda before public comments and said she would distribute it to all Township Committee members for consideration and vote.

Deputy Mayor Neibart stated Rabbi's have been asked to give an invocation at the Township Committee Reorganization meetings in past years and appreciated the suggestion that all religious faiths be considered in the future.

Mayor Monaghan allowed the following member of the public to make a comment:

Jennifer Dubeck, 307 Mendham Road West, Mendham NJ commented that religiously observant people of Jewish faith observe the Jewish Sabbath at sunset on Friday evenings, and inquired whether the Mendham Township Committee had ever had the occasion to schedule a public meeting on a Friday, which would preclude people of Jewish faith from attending a Township Committee meeting.

WHEREAS, the Plan is intended to assure that all public funds identified in the Plan are deposited in interest bearing deposits or otherwise invested in Permitted Investments.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mendham, in the County of Morris, as follows:

- 1. The Cash Management Plan of the Township of Mendham is hereby approved.
- 2. The Chief Financial Officer of the Township is hereby designated as the Custodian of the accounts covered by the Cash Management Plan.
- 3. The Cash Management Plan shall be in effect from January 1, 2023, through December 31, 2023.
- 4. The Cash Management Plan of the Township of Mendham is attached hereto and made a part of this Resolution.

CASH MANAGEMENT PLAN OF THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY

I. <u>STATEMENT OF PURPOSE</u>

This Cash Management Plan (the "Plan") is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Township of Mendham, pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to ensure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

II. <u>IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN</u>

The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Township:

- Current Fund
- o General Capital Fund
- Sewer Utility Funds
- Sewer Capital
- Payroll and Payroll Agency Accounts
- o Central Disbursement Account
- Dedicated Trust Funds (Animal, Recreation Commission, Open Space, Public Defender, Forfeited Assets, Storm Recovery, Police Donations, Other Donations, Escrow, SUI, Municipal Alliance, Off Duty – Police Road Detail, POAA, Environmental Committee, Accumulated Absence, Ralston Playground, Historic Preservation)

The custodian of the accounts shall be the Chief Financial Officer. All disbursements shall be made by checks signed by two of four authorized signatures, namely the Mayor, Deputy Mayor, Administrator, and CFO, with the exception of school funds, county funds, and debt service which may be made by wire transfers authorized by the CFO.

III. <u>DESIGNATION OF OFFICIALS OF THE TOWNSHIP AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN</u>

The Chief Financial Officer of the Township (the "Designated Official") is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan. Prior to making any such Deposits or any Permitted Investments, such officials of the Township are directed to supply to all depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file with such officials.

IV. <u>DESIGNATION OF DEPOSITORIES</u>

All depositories must be approved by the State of New Jersey with a Governmental Unit Depository Protection Act Certification (GUDPA). This is with regards to where checking, savings, trust, and escrow funds are kept. Certificates of Deposits (CD's) and investments may be, at the discretion of the Designated Official (and in accordance with all applicable state and federal laws) kept at depositories "outside" of the Township of Mendham, but within the State of New Jersey.

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of Deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

V. <u>DESIGNATION OF BROKERAGE FIRMS AND DEALERS WITH WHOM THE DESIGNATED OFFICIALS' MAY DEAL</u>

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official(s) of the Township referred to in this Plan may deal for purposes of buying and selling securities identified in this Plan as Permitted Investments or otherwise providing for Deposits. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official(s) referred to in Section III above.

VI. <u>AUTHORIZED INVESTMENTS</u>

A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:

- (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America (any investment contracts providing for resale arrangements with the supplier should be analyzed for legality and should be specifically authorized in the cash management plan);
- (2) Government money market mutual funds;
- (3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
- (4) Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
- (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units;
- (6) Local government investment pools;
- (7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281 (C.52:18A-90.4); or
- (8) Agreements for the repurchase of fully collateralized securities if:
 - (a) the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection a;
 - (b) the custody of collateral is transferred to a third party;
 - (c) the maturity of the agreement is not more than 30 days;
 - (d) the underlying securities are purchased through a public depository as defined in section 1 of P.L. 1970, c.236 (C.17:9-41); and

(e) a master repurchase agreement providing for the custody and security of collateral is executed.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

<u>Government Money Market Mutual Fund</u>. An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940," 15 U.S.C. sec. 80a-1 et seq., and operated in accordance with 17 C.F.R. sec. 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
- (c) which has:
 - (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
 - (ii) retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec.80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

<u>Local Government Investment Pool</u>. An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270.2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities;
- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, c.410 (c.52:14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and

VII. SAFEKEEPING CUSTODY PAYMENT AND ACKNOWLEDGMENT OF RECEIPT OF PLAN

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Township, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Township to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to ensure that such Permitted Investments are either received by the Township or by a third-party custodian prior to or upon the release of the Township's funds.

To assure that all parties with whom the Township deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official(s).

VIII. REPORTING REQUIREMENTS

On the first day of each month during which this Plan is in effect, the Designated Official(s) referred to in Section III hereof shall supply to the governing body of the Township a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- (a) The name of any institution holding funds of the Township as a Deposit or a Permitted Investment.
- (b) The amount of securities or Deposits purchased or sold during the immediately preceding month.
- (c) The class or type of securities purchased or Deposits made.
- (d) The book value of such Deposits or Permitted Investments.
- (e) The earned income on such Deposits or Permitted Investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.
- (f) The fees incurred to undertake such Deposits or Permitted Investments.
- (g) The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- (h) All other information which may be deemed reasonable from time to time by the governing body of the Township.

IX. TERM OF PLAN

This Plan shall be in effect from January 1, 2023 to December 31, 2023. Attached to this Plan is a resolution of the governing body of the Township approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Township Committee, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM ESTABLISHING INTEREST RATE-DELINQUENT TAXES AND SEWER FEES

BE IT RESOLVED, by the Township Committee of the Township of Mendham that the rate of interest to be charged on delinquent taxes and/or delinquent sewer charges shall be as follows:

For taxes not in arrears, 0% for nine (9) calendar days following the due date. Taxes not paid during this ten-day period shall be deemed to be in arrears as of the said first day of the month.

For taxes in arrears, 8% per annum on the first \$1,500 of the delinquency, 18% per annum on any amount in excess of \$1,500, both to be increased to the maximum allowed by law in the event of an increase in the statutory maximum.

BE IT FURTHER RESOLVED, that pursuant to N.J.S.A. 54:4-67, as amended, a penalty shall be charged to a taxpayer with a delinquency in excess of \$10,000 who fails to pay said delinquency prior to the end of the calendar year. The penalty so charged is hereby fixed at 6% of the amount of the delinquency; and if taxes are fully paid and satisfied for that calendar year by the holder of an outstanding tax sale certificate, the holder shall be entitled to receive the same 6% penalty as part of the amount required to redeem such certificate of sale; and

BE IT FURTHER RESOLVED, that interest on delinquent sewer charges will be at the same rate as for delinquent taxes; and

BE IT FURTHER RESOLVED, that pursuant to N.J.S.A. 54:5-26, in lieu of any two publications, notice to the property owner and to any person or entity entitled to notice of foreclosure pursuant to section 20 of P.L. 1948, c. 96 (C.54-104.48) may be given by regular or certified mail, the costs of which shall be added to the cost of the sale in addition to those provided in R.S. 54:5-38, not to exceed twenty-five (\$25.00) for each notice for a particular property; and that the Township Committee has determined the fee to be established for each tax sale notice for a particular property that is mailed in lieu of advertisement will be twenty-five (\$25.00) dollars.

NOW, THEREFORE BE IT RESOLVED, that the Collector of Taxes and the Collector of Sewer Fees be and is hereby directed to collect interest on taxes and sewer fees in accordance with the terms of this resolution.

This resolution shall take effect immediately.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM AUTHORIZING THE CANCELLATION OF SMALL BALANCES ON TAX AND SEWER UTILITY ACCOUNTS FOR THE YEAR ENDING DECEMBER 31, 2023

WHEREAS, N.J.S.A. 40A:5-17.1 allows for the cancellation of a tax refund or delinquency of less than ten (\$10.00) dollars.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mendham, County of Morris, State of New Jersey that authorization is hereby given that the Tax Collector process the cancellation of balances for the year 2023.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM ADOPTING 2023 TEMPORARY BUDGET OF THE TOWNSHIP OF MENDHAM

WHEREAS, N.J.S.A. 40A:4-19 of the Local Budget Law provides that where any contracts, commitments or payments are to be made prior to the adoption of the budget, temporary appropriations shall be made on or before the 30th day of the budget year; and

WHEREAS, the aggregate of such temporary appropriation is limited to 26.25% of the total appropriations in the preceding budget, exclusive of Debt Service, Capital Improvement Fund and Public Assistance, which amounts to \$2,331,437 for the Current Fund; \$54,495 for Mendham Sewer East; and \$32,769 for the Mendham West Sewer Utility.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM
TO AFFIRM THE TOWNSHIP OF MENDHAM CIVIL RIGHTS POLICY WITH RESPECT TO ALL
OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT
CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT
WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Township of Mendham to treat the public, employees, prospective employees, appointees, volunteers, and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the Township of Mendham has determined that certain procedures need to be established to accomplish this policy.

NOW, THEREFORE BE IT ADOPTED by the Township Committee of the Township of Mendham, County of Morris, State of New Jersey that:

Section 1: No official, employee, appointee or volunteer of the Township by whatever title known, or any entity that is in any way a part of the Township shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township's business or using the facilities or property of the Township.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township to provide services that otherwise could be performed by the Township.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment, and civil rights.

Section 4: The Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment, or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Township in order for the public to be made aware of this policy and the Township's commitment to the implementation and enforcement of this policy.

REMARKS FROM COMMITTEEWOMAN AMALIA DUARTE

Thanks everyone for coming out tonight! I hope you consider continuing to attend our Township Committee meetings after this evening. We're here twice a month and always open up our meetings for public comments

First, I want to congratulate the new Officers sworn in for Brookside Engine Co. No 1; Ralston Engine Co. No. 1; and the First Aid Squad.

I also want to thank the residents who were appointed this evening to our many

Our small-town government relies on volunteers. Whether it's the Environmental Commission, Planning Board, Recreation or Finance Committee – these positions take up time, energy and commitment that you could be spending elsewhere, so, ies on volunteers. Whether it's the Environmental thank you for stepping up to serve our town.

I also want to acknowledge our new Township Clerk Karen Orgera; Township Administrator Jason Gabloff, Police Chief Ross Johnson, DPW Superintendent Dave Read, Recreation Director David Guida, township attorney John Mills and all of the other staff members. They deserve the credit for running our town on a deat to day the day.

Congratulations to our new Committeewoman -- Tracey Moreen and Lauren Spirig. I am really looking forward to partnering with both of them this year on behalf of our community. Tracey and Lauren are both accomplished professionals and passionate about making our town an even better place to live. They will bring fresh perspectives to our decision-making and conversations, and I welcome their ideas to the mix!

It's historic that we have four women serving together on the dais. It's a first for our town and pretty unusual in the world of politics, where women are sorely under-represented.

We also now have a Township Committee that more accurately reflects the makeup of our community. We aren't a Red Town or a Blue Town – we truly are a Purple town. Of registered voters, we're about 38% Republican; 34% Unaffiliated;

and 28% Democrat. The election showed how thoughtful residents are in choosing candidates at the local level.

Looking ahead to the business of 2023, I am glad that we are making progress in two important areas that impact everyone in town – our Department of Public Works and roads:

- 1) There was talk about downsizing the DPW, which I did not support. The
- 1) There was talk about downsizing the DPW, which I did not support. The good news is we have hired a consultant to review our DPW operations to help us decide the optimal staffing levels what should be done by our employees and what makes sense if anything to outsource.

 2) I've advocated for us to be more strategic about road maintenance. More good news is the township's engineering firm is going to inspect roads across the entire town and compare their findings to the existing list from our DPW. Based on the engineering review, we will put together a more. our DPW. Based on the engineering review, we will put together a more comprehensive road plan that ensures we are appropriately investing in road work and seeking the right amount in state grants from the Dept. of

Looking ahead in terms of projects for this year, the marketing communications committee, which I Chair, sponsored a logo contest last summer, and the results were recently presented to the Township Committee. The next step is to make a decision on finalizing the proposed logo, so we can go ahead with installing long-awaited Welcome to Mendham Township signs. The Marketing Committee is also putting the final touches on a video to promote our community to prospective new residents.

I will continue leading the Mendhams Stigma-Free Task Force to raise awareness and educate residents about mental health and substance use. We plan to host our Second Annual Stomp Out the Stigma Walk in May for Mental Health
Awareness Month. If anyone is interested in getting involved, please let me know.

I want to thank both committees for their times and efforts

With the new police station open, I have been working on a potential plan to reuse the old Police Headquarters. Last year, we surveyed residents regarding whether to keep the building or tear it down – and an overwhelming majority of residents – 70% – favored reusing it. We held two Listening Sessions with residents in the Fall, and heard lots of ideas for how the building could be reused – from senior lunches and activities to small group meetings, teen nights and perhaps

dedicating space for the Mendham TV station, currently housed at the Old Ralston Firehouse.

Last item is I want us to follow up on the lengthy workshop we held on the Master Plan update. I want the Township Committee to consider some of the recommendations, including conducting a traffic study on our main roadways, and possibly allowing for accessory apartments either for relatives, or to generate additional income that will allow elderly residents to stay in town.

I've touched on upcoming projects and initiatives, but I want to close by too on something that's not as tangible: Our precious sense of community – whakes a town more than just a collection of homes.

In 2020, the Communications Committee surveyed new residents going back several years – pre-pandemic – to find out why they had chosen to move to

Their answers were consistent and not surprising:

High quality schools – we are meeting in a Blue Ribbon school tonight – Open space – and this election showed how much residents value open space – Sense of Community – that special feeling of living in a small town where you can get to know your neighbors; enjoy traditions like our July 4th parade, Clambake and Patriot's race; easily get involved in the community; and feel a deep connection and a sense of belonging.

Sadly of late, there's been discord in our town that challenges that sense of neighborliness and community. A resident who's lived here for nearly 30 years said to me a few days ago: "I used to feel like this was Mayberry RFD." And the operative phrase there is "used to."

We all want our community to be admired and to retain that small-town charm. It's why we moved here.

No matter your political leanings or opinions on the matter, I hope all of us can resolve to do our best to keep that sense of community alive for now and the next generation of Mendham residents. To treat our neighbors as we would hope to be treated. To support and help vulnerable members of our community. To be respectful and welcoming. To put our community first. THANK YOU!
