**WHEREAS,** the Township Committee of the Township of Mendham is subject to certain requirements of the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-6, <u>et seq.</u>; and

**WHEREAS,** the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

**WHEREAS,** it is necessary for the Township Committee of the Township of Mendham to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

WHEREAS, it is the policy of the Township of Mendham to treat employees and prospective employees in a manner consistent with all applicable employment laws and regulations including, but not limited to Title VII of the Civil Rights Act of 1964, as amended by the Equal Opportunity Act of 1972, the Age Discrimination Employment Act, the Equal Pay for Equal Work Act, the Fair Labor Standards Act, the New Jersey Law Against Discrimination, the Americans with Disabilities Act, the Family and Medical Leave Act, the Conscientious Employee Protection Act, the Public Employee Occupational Safety and Health Act, (the New Jersey Civil Service Act,) (the New Jersey Attorney General's guidelines with respect to Police Department personnel matters,) the New Jersey Workers Compensation Act, the Federal Consolidated Omnibus Budget Reconciliation Act (COBRA) and the Open Public Meeting Act; and

**WHEREAS**, the Township Committee of the Township of Mendham has determined that there is a need for personnel policies and procedures to ensure that employees and prospective employees are treated in a manner consistent with these laws and regulations.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Mendham that the synopsis of changes to the Personnel Policies and Procedures Manual attached hereto is hereby adopted.

**BE IT FURTHER RESOLVED** that these personnel policies and procedures shall apply to all Township of Mendham officials, appointees, employees, volunteers, and independent contractors. In the event there is a conflict between these rules and any collective bargaining agreement, personnel services contract or Federal or State Law, the terms and conditions of that contract or law shall prevail. In all other cases, these policies and procedures shall prevail.

**BE IT FURTHER RESOLVED** that this manual is intended to provide guidelines covering public service by the Township of Mendham employees and is not a contract. The provisions of this manual may be amended and supplemented from time to time without notice and at the sole discretion of the Township Committee of the Township of Mendham.

**BE IT FURTHER RESOLVED** that the maximum extent permitted by law, employment practices for the Township of Mendham shall operate under the legal doctrine known as "employment at will".

RESOLUTION OF THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, DETERMINING THE FORM AND OTHER DETAILS OF ITS "NOTE RELATING TO THE TRANSPORTATION BANK SHORT-TERM LOAN PROGRAM OF THE NEW JERSEY INFRASTRUCTURE BANK", TO BE ISSUED IN THE PRINCIPAL AMOUNT OF UP TO \$2,800,000, AND PROVIDING FOR THE ISSUANCE AND SALE OF SUCH NOTE TO THE NEW JERSEY INFRASTRUCTURE BANK, AND AUTHORIZING THE EXECUTION AND DELIVERY OF SUCH NOTE BY THE TOWNSHIP OF MENDHAM IN FAVOR OF THE NEW JERSEY INFRASTRUCTURE BANK, ALL PURSUANT TO THE NEW JERSEY INFRASTRUCTURE BANK'S TRANSPORTATION BANK SHORT-TERM LOAN PROGRAM

WHEREAS, the Township of Mendham (the "Local Unit"), in the County of Morris, New Jersey has determined that there exists a need within the Local Unit to provide for various road improvements, consisting of the paving and milling of municipally owned streets, including but not limited to, Hunter Glen, Carriage Hill, Green Hills Road, Indian Hollow Road, Yardley Road, Yardley Place, Knollwood Trail, East Main Street, West Main Street, and Woodland Road, and further including all work and materials necessary therefor and incidental thereto (the "Project"), and it is the desire of the Local Unit to obtain financing for such Project through participation in the transportation financing programs (the "Transportation Bank") of the New Jersey Infrastructure Bank (the "I-Bank") as established pursuant to, and in satisfaction of, the "New Jersey Infrastructure Trust Act," constituting Chapter 334 of the Pamphlet Laws of 1985 of the State (codified at N.J.S.A. 58:11B-1 et seq.), as the same has been, and in the future may from time to time be, amended and supplemented (the "I-Bank Act");

WHEREAS, the Local Unit has determined to short-term finance the design and construction of the Project through the Transportation Bank short-term loan program (the "Transportation Short-Term Loan Program") with proceeds of a short-term loan (the "Transportation Short-Term Loan") from the I-Bank;

WHEREAS, in order to (i) evidence and secure the repayment obligation of the Local Unit to the I-Bank with respect to the Transportation Short-Term Loan, and (ii) satisfy the requirements of the Transportation Short-Term Loan Program, it is the desire of the Local Unit to issue and sell to the I-Bank the "Note Relating to the Transportation Bank Short-Term Loan Program of the New Jersey Infrastructure Bank" in an aggregate principal amount of up to \$2,800,000 (the "Note");

WHEREAS, it is the desire of the Local Unit to authorize, execute, attest and deliver the Note to the I-Bank pursuant to the terms of the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the Revised Statutes of the State of New Jersey (the "Local Bond Law"), and other applicable law; and

**WHEREAS**, Section 28 of the Local Bond Law and Section 9 of the I-Bank Act permit the sale of the Note to the I-Bank, without any public offering, all pursuant to the terms and conditions set forth, respectively, therein

**NOW, THEREFORE, BE IT RESOLVED** by the governing body of the Local Unit as follows:

- Section 1. The obligation represented by the Note has been appropriated and authorized by bond ordinance #02-2023 of the Local Unit, which bond ordinance (i) is entitled "BOND ORDINANCE PROVIDING FOR VARIOUS ROAD IMPROVEMENTS IN AND BY THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, APPROPRIATING \$2,800,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$2,800,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE THE COST THEREOF." and was finally adopted by the Local Unit at a meeting duly called and held on March 13, 2023, at which time a quorum was present and acted throughout, (ii) thereafter duly published as required, and (iii) is in full force and effect, all pursuant to and in satisfaction of the terms of the Local Bond Law and other applicable law. In accordance with Section 28 of the Local Bond Law and Section 9 of the I-Bank Act, the Local Unit hereby authorizes the issuance, sale and award of the Note to the I-Bank in accordance with the provisions hereof.
- Section 2. The Chief Financial Officer of the Local Unit (the "Chief Financial Officer") is hereby authorized to determine, in accordance with the Local Bond Law, the I-Bank Act, other applicable law and pursuant to the terms and conditions hereof, (i) the final principal amount of the Note (subject to the maximum limitation set forth in Section 4(a) hereof), (ii) the dated date of the Note and (iii) the interest rate of the Note.
- **Section 3.** Any determination made by the Chief Financial Officer pursuant to the terms hereof shall be conclusively evidenced by the execution and attestation of the Note by the parties authorized pursuant to Section 4(h) hereof.
- **Section 4.** The Local Unit hereby determines that certain terms of the Note shall be as follows:
  - the principal amount of the Note, to be issued to the I-Bank, shall be an amount up to \$2,800,000;
  - (b) the maturity date of the Note shall be as determined by the I-Bank pursuant to the terms

- and provisions of the Transportation Short-Term Loan Program;
- (c) the interest rate of the Note shall be as determined by the I-Bank pursuant to the terms and provisions of the Transportation Short-Term Loan Program;
- (d) the purchase price for the Note shall be par;
- (e) the Note shall be subject to prepayment prior to its stated maturity and to repayment at or prior to its stated maturity, each in accordance with the terms and provisions of the Transportation Short-Term Loan Program;
- (f) the Note shall be issued in a single denomination and shall be numbered "NJTB-STLP-2023-1";
- (g) the Note shall be issued in fully registered form and shall be payable to the registered owner thereof as to both principal and interest in lawful money of the United States of America: and
- (h) the Note shall be executed by the manual or facsimile signatures of the Mayor and the Chief Financial Officer under official seal or facsimile thereof affixed, printed, engraved or reproduced thereon and attested by the manual signature of the Local Unit Clerk.

**Section 5.** The Note shall be substantially in the form approved by the Transportation Bank and reviewed by bond counsel to the Local Unit.

**Section 6.** The law firm of McManimon, Scotland & Baumann, LLC is hereby authorized to arrange for the drafting, preparation and printing of the Note, which law firm may authorize Chiesa Shahinian & Giantomasi PC, bond counsel to the I-Bank for the Transportation Short-Term Loan Program, to arrange for same.

Section 7. The Local Unit Mayor, Chief Financial Officer and Local Unit Clerk (each an "Authorized Officer") are hereby further severally authorized to (i) execute and deliver, and the Local Unit Clerk is hereby further authorized to attest to such execution and to affix the corporate seal of the Local Unit to, any document, instrument or closing certificate deemed necessary, desirable or convenient by the Authorized Officers, in their respective sole discretion, after consultation with counsel and any advisors to the Local Unit and after further consultation with the I-Bank and its representatives, agents, counsel and advisors, to be executed in connection with the issuance and sale of the Note and the participation of the Local Unit in the Transportation Short-Term Loan Program, which determination shall be conclusively evidenced by the execution of each such certificate or other document by the party authorized hereunder to execute such certificate or other document, and (ii) perform such other actions as the Authorized Officers deem necessary, desirable or convenient in relation to the execution, issuance and delivery of the Note and the participation of the Local Unit in the Transportation Short-Term Loan Program.

### RESOLUTION 2023-187 RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM FOR STATE/FEDERAL FUNDING DUE TO EMERALD ASH BORER DESTRUCTION OF ASH TREES

**WHEREAS**, the United States and especially New Jersey has been hard hit by the Emerald Ash Borer (EAB), a voracious pest that has destroyed hundreds of thousands of Ash trees and has devastated the canopy of trees throughout the municipalities of Morris County since it was discovered in New Jersey in 2014; and

**WHEREAS**, as Ash trees die, they become quite brittle and are a hazard to the community and need to be removed to minimize risk to life and property; and

WHEREAS, each municipality has incurred substantial costs to remove, destroy and quarantine (to avoid the spread of the EAB) these hazard trees; and

**WHEREAS**, each municipality should be replacing the lost tree canopy with a different species of trees as soon as possible to maintain the ecosystem; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Committee of the Township of Mendham urges the state of New Jersey and U.S. federal government to provide funding to assist municipalities in dealing with this extraordinary and unanticipated cost of removing, destroying, and quarantining the infected Ash trees and replacing the lost tree canopy; and

**BE IT FURTHER RESOLVED** that copies of the resolution be transmitted to all members of the New Jersey State Legislature, the Lieutenant Governor, the Governor of the State of New Jersey; and to all our representatives in Congress.

### RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM RECOGNIZING THE GROWING PROBLEM OF ANTISEMITISM IN AMERICA AND CALLING FOR THE ADOPTION OF EDUCATIONAL TOOLS TO ADDRESS IT

**WHEREAS**, the Township of Mendham stands with other municipalities across New Jersey, including the City of Summit, Westfield, Berkeley Heights, New Providence, Scotch Plains, Millburn, Livingston, and many more, against antisemitism, and;

WHEREAS, antisemitic attacks across New Jersey have been on the rise since 2019, and;

WHEREAS, such attacks across the nation have risen by almost 400% so far in 2023 over last year, and;

WHEREAS, the recent American Jewish Committee (AJC) State of Antisemitism in America Report found that more than one in three American Jews (37%) say they have been victims of antisemitism over the past five years, and;

**WHEREAS**, antisemitism, including harassment on the basis of actual or perceived Jewish origin, ancestry, ethnicity, identity, affiliation, or faith, remains a persistent, pervasive, and disturbing problem in American society, and;

**WHEREAS**, Jews continue to be a targeted minority in the United States and are consistently the most likely of all religious groups to be victimized by incidents of hate, and such incidents are increasing at an alarming rate, and;

**WHEREAS**, we acknowledge that because of these attacks, synagogues across the country have felt compelled to re-evaluate their own security measures to keep their congregations safe, and;

**WHEREAS**, Township of Mendham officials and institutions have a responsibility to protect citizens from acts of hate and bigotry, including antisemitism, and must be given the tools to do so, and;

**WHEREAS**, valid monitoring, informed analysis and investigation, and effective policy making all benefit from accurate and uniform definitions, and;

**WHEREAS**, the International Holocaust Remembrance Alliance (IHRA), by consensus vote of its member states, adopted a Working Definition of Antisemitism in May 2016, which has become the internationally recognized, authoritative definition of antisemitism for use by governments and international organizations. That definition reads in full:

"Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish and non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."

Contemporary examples of antisemitism in public life, the media, schools, the workplace, and in the religious sphere could, taking into account the overall context, include, but are not limited to:

- Calling for, aiding, or justifying the killing or harming of Jews in the name of radical ideology or an extremist view of religion.
- Making mendacious, dehumanizing, demonizing, or stereotypical allegations about Jews as such
  or the power of Jews as collective such as, especially but not exclusively, the myth about a world
  Jewish conspiracy or of Jews controlling the media, economy, government, or other societal
  institutions.
- Accusing Jews as people being responsible for real or imagined wrongdoing committed by a single Jewish person or group, or even for acts committed by non-Jews.
- Denying the fact, scope, mechanisms (e.g., gas chambers) or intentionality of the genocide of the Jewish people at the hands of National Socialist Germany and its supporters and accomplices during World War II (the Holocaust).
- Accusing the Jews as a people, or Israel as a state, of inventing or exaggerating the Holocaust.
- Denying the fact, scope, mechanisms (e.g., sexual and gender-based violence) or intentionality of

the attacks on civilians within Israel by Harakat al-Muqawama al-Islamiya (HAMAS) and its allies on October 7, 2023.

- Accusing Jewish citizens of being more loyal to Israel, or to the alleged priorities of Jews worldwide, than to the interests of their own nations.
- Denying the Jewish people their right to self-determination, e.g., by claiming that the existence of a State of Israel is a racist endeavor.
- Applying double standards by requiring of the State of Israel a behavior not expected or demanded of any other democratic nation.
- Using the symbols and images associated with classic antisemitism (e.g., claims of Jews killing Jesus or blood libel) to characterize Israel or Israelis.
- Drawing comparisons of contemporary Israeli policy to that of the Nazis.
- Holding Jews collectively responsible for actions of the State of Israel.

#### And,

WHEREAS, antisemitic acts are criminal when they are so defined by law (for example, denial of the Holocaust or distribution of antisemitic materials in some countries), and;

**WHEREAS**, the IHRA Working Definition has proven to be an essential tool used to help determine contemporary manifestations or antisemitism, and;

**WHEREAS**, in the United States, the IHRA Working Definition is utilized by various government agencies, including the U.S. Department of State and the U.S. Department of Education, and can be utilized by law enforcement agencies in monitoring, training, and education, and;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Mendham:

- 1. It does hereby adopt the non-legally binding International Holocaust Remembrance Alliance (IHRA) Working Definition of Antisemitism in full.
- 2. It will ensure that the IHRA Working Definition of Antisemitism is available as an educational resource for the Board of Education, Police Department, and other agencies responsible for addressing antisemitism and other forms of discrimination.
