DISCUSSION

Document Management

Mr. Gabloff and Ms. Coppinger met with File Bank and Foveonics to discuss options for document management and storage. The two companies are similar but different in their process; File Bank is a scan as you go process with on-site storage, Foveonics scans all documents (by department) in one sitting. Mr. Gabloff's recommendation for the township's current needs is File Bank. Mr. Orlins made a motion to move forward with File Bank's proposal; seconded by Ms. Neibart. All members present voted in favor of the proposal (roll call vote).

Solar Panels

Mayor Monaghan noted that the solar panel discussion was tabled.

LIAISON REPORTS

Ms. Duarte announced that the Environmental Commission will have a presentation at the next meeting on the Wildlife Federation Program that they are looking to get started. Also, present the Boys Scouts with proclamations. The Stigma-Free Task Force received some funding and they will be hosting a meeting with the Rotary Club.

Ms. Neibart announced that the Recreation Department will host a Valentine's Day Stroll at Pitney Park, Friday, February 11th. Also, there will be a meeting with the sports team on turf fields.

Mayor Monaghan noted that Public Works is working through some covid related manpower. The police department is moving ahead with training. The library is continuing with their programs and are in the middle of their fundraising.

Mr. Baio announced that Historic Preservation Committee (HPC) had a meeting and some of the responsibilities have been divided, with subcommittees to address the four major subject matters of HPC. The four subject matters are the Seed House to determine the use and long-term maintenance and management, the collection management and space planning, fundraising opportunities and scanning and digital assessment management.

Mr. Orlins noted that the Finance Advisory Committee had a meeting this afternoon, to set the table on the new process with the new Chief Financial Officer. He noted that there is very promising overview of appropriations. He encouraged residents to get out and vote in the special election.
