The Township Committee had a lengthy discussion on Resolution 2024-054. Mr. Monaghan questioned if this grant money was to be used for the Mosle Lighting project.

Mayor Neibart shared that the Twin Boro Bears are no longer interested in helping to fund the lights at Mosle Field as the lights suggested by the Mosle Committee will not meet the needs of the group. Mayor Neibart further commented on the need to still discuss lighting the parking lot and pathway. The grant would not cover the portable/semi-permanent lights.

Ms. Moreen suggested an amendment to say Mount Pleasant and Meadowood Recreational Facilities.

Ms. Moreen further suggested revisiting the 4 Towns Recreation Plan from 14 years ago to see what sports are being underserved in each town.

Mr. Monaghan strongly opposes this grant application resolution as there isn't a project in place.

DISCUSSION

Town Hall Renovation Update

Mr. Gabloff reported that the project is moving forward. Waiting for the sprinkler contractor to finish the shop drawings for approval. Waiting on NJ American Water to do a pressure test. HVAC unit and duct work needs to be slightly modified. A change order will need to be done for this. The mold issue in the children's room needs to be remediated.

Mosle Light Project Update

Mr. Gabloff commented that the Twin Boro Bears is not willing to put money into the proposed semipermanent lights that was proposed by the Mosle working group. Twin Boro Bears will continue to use what they have been. Twin Boro Bears requested that the Township would still be interested in lighting the parking lot and pathway with temporary lights.

The Township Committee discussed how the Township would like to proceed with the lights for the parking lot and pathway. It was further discussed that the Twin Boro Bears should be encouraged to put up signage to warn people of the diesel light towers. The price of each diesel tower would be around \$25,000.00. These lights are portable and could be used at different locations throughout the Township. One or two light towers would be needed.

Update & TC Letter Re: Preservation Credit Work- A4/S50 Affordable Housing Bill

Mayor Neibart drafted and read aloud on behalf of the Township Committee to be forwarded to Senate representatives and Assembly members of New Jersey outlining the need for sustainable land-use practices and preservation of the environment in regard to bills A4/S50.

Raritan Headwaters Association-Water Restoration & Protection Plan-appointing members

The Township Committee discussed that a member of the Open Space Trust Committee and Environmental Committee be appointed to this advisory committee. Mayor Neibart will reach out to each Committee to solicit those members.

OPEN TO THE PUBLIC

Mayor Neibart opened for public comments.

Anthony Reitano, 3 Carriage Hill Drive, Mendham, NJ commented that making the investment to light the parking lot for a single organization is a burden on the taxpayers. Currently there are 16 light towers. The owner of the land should be named as an additional insured for liability purposes and protect the Township. Mr. Reitano further commented that Twin Boro Bears should be self-sufficient.

Ed Coury, 87 Mosle Road, Mendham, NJ commented that the Mosle Ad Hoc Committee put in a lot of time and energy into the process of semi-permanent lights. Mr. Coury is still in favor of having an Environmental Impact Study done to see what the impact will be if lights are used for the parking lot and pathway.

Mary Shay-Milea, 1 Carriage Hill Drive, Mendham, NJ commented that she is concerned on how things will be monitored at Mosle Field. Ms. Milea further commented that this project and discussion needs to come to a close as the process has been exhausting.

Seeing and hearing no one wishing to be heard, Mayor Neibart asked for a motion to close public comments.

Motion to close public comment period was made by Ms. Duarte and seconded by Ms. Spirig, with all members present voting in favor, no one opposed.

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12

WHEREAS, the Township Committee of the Township of Mendham is subject to certain requirements of the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-6, <u>et seq.</u>; and

WHEREAS, the <u>Open Public Meetings Act</u>, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Township Committee of the Township of Mendham to discuss in a

not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4- I designated below:
(1) Matters Required by Law to be Confidential: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.
(2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.
(3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
(4) Matters Relating to Collective Bargaining Agreements: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
(5) Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.
(6) Matters Relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.
(7) Matters Relating to Litigation, Negotiations, and the Attorney-Client Privilege: Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
(8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose right could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
(9) Matters Relating to the Potential Imposition of a Penalty: Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Mendham, in the County of Morris, State of New Jersey, assembled in public session on **February 26, 2024 at 6:30 P.M**. in the Mendham Township Middle School, 16 Washington Valley Road, Brookside, New Jersey, that the Township Committee shall meet in Executive Session, from which the public shall be excluded, for the discussion of matters relating to the specific items designated above.

BE IT FURTHER RESOLVED that it is anticipated that the deliberations conducted in closed session may be disclosed to the public upon the determination of the Township Committee that the public interest will no longer be served by such confidentiality.

ORDINANCE NO. 01-2024 AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM MORRIS COUNTY, NEW JERSEY NATIVE PLANT ORDINANCE

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Sec. 1. TITLE

This ordinance shall be known and may be cited as "Municipality of Mendham Township Landscape Ordinance Promoting the Use of Native Vegetation."

WHEREAS, native plants are localized, well adapted to the local soils and climate, tend to be more insect and disease resistant, and require less watering and fertilizing than non-native plants.

WHEREAS, local governments use native plant ordinances to improve the landscape principles that guide landscaping of all new developments. Many communities find that the use of appropriate native vegetation in local landscaping helps achieve water conservation goals, preserves habitat, and reduces landscaping maintenance costs.

WHEREAS, wildlife such as birds are more attracted to the native plants with which they co-evolved, and use such plants for food, cover, and rearing their young.

WHEREAS, native plants, having evolved in the climate, are extremely hardy and therefore have lower maintenance and replacement costs.

WHEREAS, native plant usage helps restore the ecological balance we have lost through development.

Sec. 2. PURPOSE AND INTENT

The purpose of this ordinance is to establish guidelines for the design, installation, and maintenance of landscaped areas that require the use of native vegetation and to promote the preservation of indigenous plant communities. The Municipality recognizes the significant benefits of establishing and protecting native vegetation and, therefore, the necessity to require the use of native vegetation in all newly planted public landscaped areas within the Municipality. A specific garden with historical or other special significance can request an exception to this ordinance by approval from the Environmental Commission, provided that plants do not appear on the New Jersey Invasive Species Strike Team's Do Not Plant List. The Municipality strongly recommends that developers, property owners and landscapers consult the New Jersey Invasive Species Strike Team's Do Not Plant List, and plant native plant species rather than species on this list for all new plantings in Mendham Township wherever possible.

It is the intent of this ordinance that these minimum landscape guidelines be incorporated in order to help combat the climate crisis, species extinction and to promote public health, safety, and welfare by: (a) Acknowledging that native plants are the foundation of the food web and diverse native plants are required to sustain healthy biodiversity; (b) acknowledging pollination is an essential ecological survival function, and without native plants and the pollinators that depend on them, the human race and all of earth's terrestrial ecosystems will not survive; (c) doing our part to reverse the massive decline in native pollinator populations from widespread use of pesticides in agribusiness, loss of habitat from development, and from excessive use of non-native plants in landscaping; (d) protecting and promoting genetically diverse and appropriate native vegetation; (e) promoting microhabitats in Township areas for the conservation of wildlife by establishing new, and maintaining and connecting existing, wildlife habitat; (f) creating larger, more connected plant populations and helping ensure the future of native plant species by increasing their ability to migrate in response to changes in climate; (g) promoting public health through the long term, widespread adoption of diverse native plantings; and (h) educating residents on the importance of native plant species and native pollinators to the ecosystem.

Sec. 3. DEFINITIONS

- (a) Invasive Plant: a plant reproducing outside its native range and outside cultivation that disrupts naturally occurring native plant communities by altering structure, composition, natural processes, or habitat quality. Refer to the New Jersey Invasive Species Strike Team's Do Not Plant List for an up-to-date list.
- (b) Landscaped Area: the entire parcel less the building footprint, driveway, non-irrigated portions of parking lots, hardscapes such as decks and patios, and other non-porous areas. Water features are included in the calculation of landscaped areas.
- (c) Landscaping: any combination of living plants and non-living landscape material such as rocks, pebbles, sand, mulch, walls, fences, or decorative paving materials.
- (d) Native Plant: those species of plants naturally occurring within a specific habitat or biogeographical region prior to European contact, according to best scientific and historical documentation. Refer to Jersey-Friendly Yards for a database.
- (e) Pollinators: animals (primarily insect, but sometimes birds or mammals) that fertilize plants, resulting in the formation of seeds and the fruit surrounding seeds, that humans and other animals rely on to

produce nuts and fruits that are essential components of a healthy diet, and that the majority of flowering plant species found world-wide rely on to make the seeds that will become the next generation of plants. (f) Straight Species: a native plant that is not a cultivar or has not been bred to emphasize or minimize certain traits of the parent plant. Naturally occurring hybrids of native plants shall be considered as Straight Species for the purpose of this ordinance.

Sec. 4. APPLICABILITY

After the effective date of this ordinance, these guidelines shall apply to all public town buildings and public land within the incorporated and unincorporated areas of the Municipality.

Sec. 5. BEST PRACTICES FOR PLANTING

The Municipality shall, where possible, use the Jersey-Friendly Yards best practices for environmentally friendly landscaping which includes guidance on planning, maintaining healthy soil, watering wisely, fertilizing less, avoiding pesticides, and creating habitat for wildlife.

Sec. 6. INVASIVE PLANTS FORBIDDEN

After the effective date of this ordinance, the Municipality shall not use or install any invasive plant in any Municipal property. Landowners and developers shall be encouraged to plant native plants and avoid planting invasive plants on their property.

Sec. 7. PRIORITIZING STRAIGHT SPECIES

The Municipality shall, to the extent possible and to the extent such plants are reasonably available, prioritize using and installing native plants that are straight species on any Municipal property. Cultivars may need to be chosen for disease resistance, size/height management or other attributes. Care should be taken to ensure that leaf and flower color as well as flower form is as close to the straight species as possible.

Sec. 8. SEVERABILITY

If any portion of this article is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate provision and shall not affect the validity of the remaining portions of the article.

Sec. 9. EFFECTIVE DATE

This ordinance shall take effect 30 days after it is enacted by the Municipality; provided, however, that this ordinance shall not apply to any plantings carried out pursuant to existing contracts, invitations to bid, or designs completed prior to the effective date of this article.
