OPEN TO THE PUBLIC

Diana Orban Brown – Ironia Road – Ms. Brown asked the township committee to consider recording the meetings to make them accessible to residents that cannot attend the finance advisory committee meetings at 5:30 pm. She asked the township committee to address the "unsolicited gifts" from residents; donations that end up on township property without approval from the township.

Patricia Zimmerman – W. Main Street – expressed that she is delighted with the Zoom features.

Peter Banos – 47 Ironia Road – Mr. Banos commented on the Backer Farm's Brewery Application to the Morris County Agriculture Development Board (MCADB). He noted that the MCADB would review the three noise complaints. Mr. Banos asked several questions about the attorney representing the township on the brewery proposal.

George Koenig – 13 North Gate Road – Congratulated the Boy Scouts and Kylie Bailin, noting that he and his wife put in a native garden and encouraged others to do the same. He also would like the township committee to address Mr. Banos' questions.

Barrett Kolton -3 North Gate Road - Ms. Kolton had several questions regarding the attorney representing the township on the Backer Farm Brewery application. She asked for the attorney's name and background; asked if the attorney will represent the interest of both the township and the affected residents; could the committee update the residents, regularly, on the status of the application; and can the attorney be made available to meet with concern residents.

OPEN TO THE PUBLIC

Peter Banos – 47 Ironia Road – He reiterated Ms. Kolton's question, will the attorney (Backer Farm) meet with residents and will you formulate a position.

Motion to close hearing persons present made by Mr. Orlins; Seconded by Mr. Baio. All members presented voted in favor.

DISCUSSION

Ms. Duarte followed up on Ms. Brown's comment regarding the Finance Advisory Committee; she agrees that we should be recording the meetings and suggested having the meetings on Zoom. She noted that the process is very different from last year, when it was a joint effort between the township and finance committees at all the meetings. She expressed that it seems that the finance committee is really in the driver's seat and will be doing a lot of the work and then presenting their findings to the township committee. She's really worried that the township committee will not have the opportunity to express our points of view until it's late in the process. In addition, she's worried that the township committee will be expected to rubber-stamp the budget by the time it gets to the end of the budget.

Ms. Neibart noted that last year was a little disorganized; some of it had to do with it being on Zoom and other technological limits. Also, last year we had a finance committee that couldn't activate to the extent that it could have because the five township committee members monopolized the conversation. Ms. Neibart does not mind the process because it's public; she noted that she has voted against budgets that have come out of the finance committee, and she has never rubber-stamped a budget. She plans to be incredibly analytical and assess the budget on its merit and what it will be providing residents.

Mr. Baio expressed that when the township committee selected the finance committee members, he entrusted those members to hold the budget. He is one of those people that do not want to see taxes rise and doesn't want to see an expansion of municipal services unless there is a high demand for it. He knows that there is pressure to increase programs in recreation; his position is that recreation should grow slowly, less than 2%.

Ms. Duarte noted that if she comes to the finance committee meetings that she's not allowed to engage due to the Open Public Meetings Act (OPMA).

Mayor Monaghan commented on the OPMA rules. He also noted that all decisions will always come to the dais. He mentioned that the issues with the audio make it challenging to record and stream the meeting.

Mr. Orlins commented that every town does the budget process differently, and Mendham Township has its process, which works very well.

Ms. Neibart announced that the recreation committee, sports leagues, and the professional staff are looking into building a turf field in the town. In addition, there will be workshops and information sessions to allow for every resident to provide feedback.

LIAISON REPORTS

Mr. Monaghan announced that the Board of Health had their reorganization meeting last week.

Mr. Orlins announced that the \$19 million Mendham township School District Referendum passed.

Mr. Monaghan commented on the new police department noting the weather did slow them down a little bit but it's not significations; so, everything is moving along very well.

ADJOURN

Motion to adjourn made by Mr. Orlins; Seconded by Ms. Duarte. The Township Committee adjourned at 8:58 PM.
